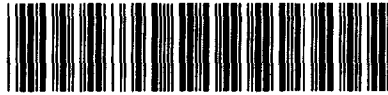

Your assessing officials completed a general reassessment of all real property in the county first effective for property taxes payable in 2003. The reassessment was necessary to comply with Indiana law. The Indiana General Assembly has increased the property tax replacement credit and made other changes to the property tax system to substantially reduce the effects that this reassessment may have on your property tax liability. Due to the Indiana General Assembly's actions, the average 2004 property tax bill for homeowners in Putnam County was approximately forty eight percent (48%) lower than it would have been.
