Item 1 Basis for Claim

OX (AL) LLC and its successors, and assigns (collectively, "Claimant") assert the following claims (collectively, the "Claim") against OXFORD AUTOMOTIVE, INC (the "Debtor")

- A Any and all claims, rights and/or remedies Claimant may have, arising out of and/or relating to that certain guaranty and suretyship agreement (the "Guaranty"), dated as of March 28, 2003, between Claimant, as landlord, and Debtor, as guarantor, in connection with the Lease dated as of March 28, 2003 (the "Lease") between Claimant, as landlord, and Oxford Automotive Alabama, Inc , as tenant ("Tenant"), with respect to certain real property and improvements located in McCalla, Alabama, including (i) the tract of real property described on Exhibit A to the Lease, together with all appurtenances thereto (collectively, the "Land"), (ii) the building, structures and other improvements on or constructed on the Land, and (iii) the fixtures, equipment and other personal property described on Exhibit B to the Lease

- B On December 1, 2004, Claimant, as landlord, and Protective Life Insurance Company, as lender, signed a Consent to Assignment Agreement (the "Assignment Agreement") to Debtor, as guarantor ("Guarantor") and Tenant In accordance with the Assignment Agreement, (i) assignee under the Lease expressly assumed and agreed to bound by and to perform and comply with, all obligations under the Lease after the effective date of the assignment, (ii) Tenant affirmed its obligations under the Guaranty, and (iii) Guarantor affirmed its obligations under the Lease Claimant is filing this Claim as a protective claim and seeks recovery for any and all liability in connection with the Guaranty arising as a matter of law or equity prior to the effective date of the Assignment (as defined in the Assignment Agreement), including, but not limited to, with respect to any Environmental Violation(s) (as defined in the Lease)

Item 2 Date debt was incurred

The Claim was incurred as of the date of the Lease, and thereafter

Item 4 Total Amount of Claim

As of December 7, 2004, the petition date, the total amount of the Claim was undetermined

Items 5 and 6 Secured Claim and Unsecured Priority Claim

The Claim is partially secured to the extent that claimant has a right of setoff, recoupment, credit or landlord's lien The balance of the claim is unsecured, except to the extent entitled to administrative claim priority

Item 8 Supporting Documentation

The Debtor has copies of the Guaranty, Lease documents and the Assignment Agreement However, copies of any applicable documents not attached hereto will be provided upon written request to Claimant

Note Claimant reserves the right to amend and/or supplement this proof of claim at any time and in any manner, and to file additional proofs of claim for additional claims which may be based on the Guaranty and respective rights and obligations arising under the Lease. In addition, Claimant reserves the right to attach or bring forth additional documents supporting its claims and additional documents that may become available after further investigation and discovery. Claimant further reserves the right to file proofs of claim for administrative expenses.

Note This proof of claim is filed pursuant to the Notice of Extension of Bar Date to File Proofs of Claim setting February 1, 2005 as the deadline to file proofs of claim against the Debtor. The filing of this proof of claim shall not constitute (a) a waiver or release of the rights of Claimant against the Debtor or any other person or property, (b) a waiver of the Claimant to contest the jurisdiction of this Court with respect to the subject matter of the claims set forth herein, any objection or other proceeding commenced with respect thereto or any other proceeding commenced in this case against or otherwise involving the Claimant, or (c) an election of remedies or choice of law.



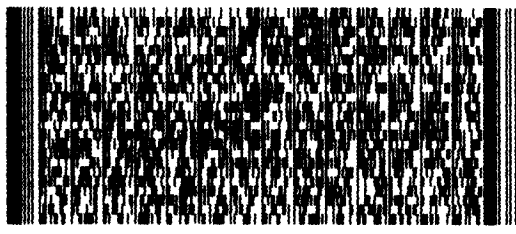

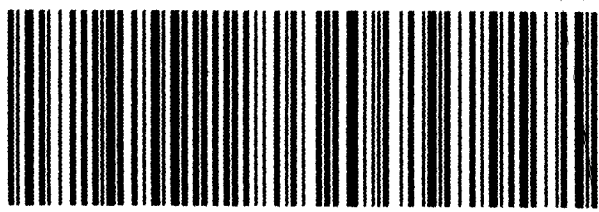
