**MOTION FOR ADMISSION PRO HAC VICE PURSUANT
TO LOCAL BANKRUPTCY RULE 2090-1**

I, William E. Steffes (“Movant”), a partner of the law firm of Steffes, Vingiello & McKenzie LLP (“SVM”) and a member in good standing of the Bar of the State of Louisiana and admitted to practice before the United States District Court for the Eastern District of Louisiana, hereby move this Court for entry of an order authorizing Mark K. Thomas, Michael S. Terrien, Peter J. Young, and of the law firm of Jenner & Block LLP (“J&B”) with its offices in Chicago, Illinois, to practice *pro hac vice* before the United States Bankruptcy Court for the Eastern District of Louisiana, to represent the Official Committee of Unsecured Creditors (the “Committee”) of the above-captioned debtors and debtors in possession (collectively, the “Debtors”). There are no disciplinary proceedings against him. A certified copy of a certificate issued by the District Court of Illinois verifying that Michael S. Terrien is in good standing is attached hereto as Exhibit "B."

Peter J. Young is a member in good standing of the Bar of the State of Illinois and is admitted to practice in all Courts of the State of Illinois and the United States District Court for the Northern Districts of Illinois. There are no disciplinary proceedings against him. A certified copy of a certificate issued by the District Court of Illinois verifying that Peter J. Phillip W. Nelson is a member in good standing of the Bar of the State of Illinois and is admitted to practice in all Courts of the State of Illinois and the United States District Court for the Northern Districts of Illinois. WHEREFORE, Movant requests that the Court approve this Motion and authorize Mark K. Thomas, Michael S. Terrien, Peter J. Young, and Phillip W. Nelson to appear *pro hac vice* in association with the Movant as national counsel to the Committee and granting such other relief as this Court deems necessary.
