**ORDER ALLOWING INTERIM COMPENSATION FOR THE PERIOD
MARCH 14, 2006 THROUGH JUNE 30, 2006 FOR THE LAW FIRM OF
HELLER, DRAPER, HAYDEN, PATRICK & HORN, L.L.C.,**

The First Interim Application for Compensation for the Period March 14, 2006 through June 30, 2006 (the “Application”) [P-1384] for the Law Firm of Heller, Draper, Hayden, Patrick & Horn, L.L.C. (“Heller Draper”) came to be heard on October 18, 2006 at 2:00 p.m. In the Application, Heller Draper sought interim compensation in the amount of One Million Two Hundred Thirty-One Thousand Three Hundred Seventy-Four and Three Tenths (\$1,231,374.30) Dollars and reimbursement of expenses advanced in the amount of One Hundred Eight Thousand Two Hundred Thirty and Nine Hundredths (\$108,230.09) Dollars;


The Court having reviewed the Application, and considering the representations of counsel for Heller Draper and the U.S. Trustee’s Office, that in response as raised by the U.S. Trustee as to the Application, Heller Draper has agreed to reduce its professional fees in the amount of \$5,500;

IT IS HEREBY ORDERED that Heller Draper is allowed interim compensation for the period March 14, 2006, through June 30, 2006, in the amount of One Million Two Hundred Twenty-Five Thousand Eight Hundred Seventy-Four and 30/100

(\$1,225,874.30) and One Hundred Eight Thousand Two Hundred Thirty and Nine Hundredths (\$108,230.09) Dollars for expenses incurred; and

IT IS HEREBY FURTHER ORDERED that the U.S. Trustee's comments and objections relating to the rates charged for paralegals and/or law clerks is preserved and reserved to be considered in connection with the next application for compensation.
