
Dear Court, Judge, or Governing Authority:

I am submitting a Proof of Claim for the unpaid balance of my 2008 Incentive Compensation. This compensation is owed to me by one or more of the following: Opus West LP, Opus West Corporation, Opus West Construction Corporation, O.W. Commercial, Inc., and Opus West Partners, Inc. This is not meant to be an all inclusive list, and if another entity is deemed to be responsible for the debt they shall still be held liable.

I have included documentation which reflects what was paid out so far vs. what is still owed to me. There is an outstanding balance of \$5,744.50 due to me from the partial 'Incentive Calculation' that was paid in March. (This was based off of the \$11,489.00 Total, and the fact that I was only paid out 50% or \$5,744.50 of that total.) There is also the 'Opus West Corporation vs. Business Plan' portion of the Incentive Compensation that was not yet calculated. Based upon a 100% factor the dollar amount owed would be \$3,750.00. (This could be factored up or down slightly depending on the actual numbers.) We were told that these numbers were not available yet in March, and we were never given any data on the actual numbers. That would put the combined total currently owed to me at \$9,494.50.
