**AGREED ORDER RESOLVING DEBTORS' FIRST OMNIBUS OBJECTION
REGARDING CLAIMS BY LIBERTY MUTUAL INSURANCE COMPANY AND ITS
AFFILIATES [DOCKET NO. 982]**

This matter is before the Court upon the Debtors' First Omnibus Objection to Certain Claims by Liberty Mutual Insurance Company and Its Affiliates, which is currently scheduled for hearing on January 14, 2013. Upon agreement of the parties as reflected by the signatures below and good cause appearing thereof, it is ORDERED that

- (1) The claims of Liberty Mutual Insurance Company and its subsidiaries and/or affiliates listed in the column labeled "Claim to Be Expunged" on Exhibit A attached hereto (collectively, the "Expunged Claims," and each an "Expunged Claim") shall be expunged as duplicate claims;
- (2) Any claim of Liberty Mutual Insurance Company, its subsidiaries, and/or its affiliates against any Debtor, including without limitation the claims listed in the column labeled "Surviving Claim" on Exhibit A attached hereto, that is not an "Expunged Claim" shall be unaffected by this Agreed Order and shall be deemed to be a valid

claim on behalf of Liberty Mutual Insurance Company and its subsidiaries and its affiliates, subject to the reservation of rights by the Debtors hereunder; and

(3) The Debtors reserve all rights in the future regarding all claims of Liberty Mutual Insurance Company and its Affiliates filed in the Debtors' bankruptcy cases.
