2. The stay under 11 U.S.C. §362(a) will continue in effect pending further order of the Court.
3. The Alternative relief requested in the Motion will not be heard pursuant to Local Rule 4001-1(a), provided nothing in this Order shall be deemed to prohibit any party from requesting that the

Court hear the alternative relief, or any other matter, at the final hearing, provided that such request otherwise complies with the Bankruptcy Rules and the Local Rules.
