***Reference: PMGI HOLDINGS INC. and other companies – Proofs of claim in insolvency procedure (Case No. 13-12404)***

With reference to the insolvency proceeding opened by the Bankruptcy Court of Delaware towards PMGI HOLDINGS INC (Case No. 13-12404) and other companies belonging to the same group, we point out that:

- on 19<sup>th</sup> December 2014 (protocol no. 27439) it was asked this Company, as agent managing the insolvency procedure, to lodge accountancy documents and any element useful to correctly identify the transactions made in Italy by the companies resulting as debtors towards Italian Tax Administration;

- in the mentioned communication, it was pointed out that in case of lacking answer, this Administration would have considered the amounts indicated in the proofs of claim, submitted in attachment to the communications issued by the Bankruptcy Court of Delaware, as tax to be claimed within the procedure;

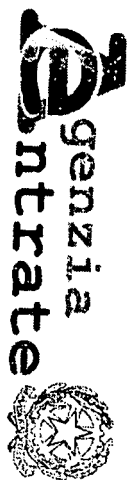

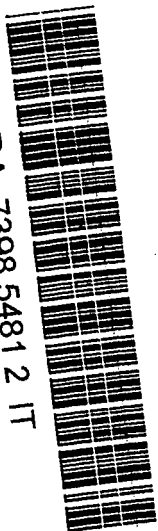

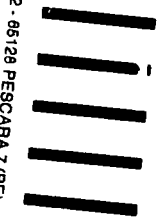
