The undersigned, on behalf of Bernstein, Shur, Sawyer & nelson (“BSSN”) hereby certifies that, as of the date hereof, he has received no answer, objection or other responsive pleading to the Statement of Fees for Services Rendered and Out-of-Pocket Expenses as Co-Counsel to the Debtors for Period Beginning November 1, 2004 and Ending November 30, 2004 (the “BSSN Monthly Statement”)[Docket No. 926], which was filed on January 26, 2005. The undersigned further certifies that he has caused the Court’s docket in this case to be reviewed and no answer, objection or other responsive pleading to the BSSN Monthly Statement appears thereon. Pursuant to this Court’s Order Under 11 U.S.C. §§ 331 and 105(a) Establishing Procedures for Interim Compensation and Reimbursement Expenses for Professionals (the “Interim Procedures Order”) [Docket No. 217] entered on June 24, 2004, objections to the BSSN Monthly Fee Statement were to be filed and served twenty (20) days after the filing and service of the BSSN Monthly Fee Statement. That response deadline was February 15, 2005.

Pursuant to the Interim Procedures Order, BSSN is entitled to payment of \$9,673.65 which represents 90% of the fees (\$10,748.40) and \$537.64, which represents 100% of the expenses, requested in the BSSN Monthly Statement for the period November 1, 2004 through November 30, 2004, upon the filing of this Certification and without the need for entry of a separate Court order approving the BSSN Monthly Statement. The Debtors are authorized to pay to BSSN the amount due of \$10,211.29.
