You have received this notice because you are party to a contract or lease listed on Schedule 8.2(a).

PLEASE TAKE FURTHER NOTICE that if you wish to challenge the Cure Amount listed on Schedule 8.2(a) for a contract or lease to which you are a party, you must file an objection (a “Cure Objection”) with the United States Bankruptcy Court for the District of Maine (the “Bankruptcy Court”), 537 Congress Street, 2nd Floor, Portland, ME 04101, prior to the date on which the Clerk of the Bankruptcy Court enters an order confirming the Plan on the Docket of the Bankruptcy Court (the “Confirmation Date”). The hearing to consider confirmation of the Plan is scheduled for March 24, 2005 at 10:30 a.m. The Cure Objection also must be served, so as to be received, on or before the date the motion is filed, by the following parties:

Schedule 8.2(a)

SCHEDULE 8.2(a) SHOULD ONLY BE READ IN CONJUNCTION WITH THESE HEADNOTES, WHICH CONTAIN VALUABLE INFORMATION REGARDING THE DATA CONTAINED THEREIN.

Schedule 8.2(a) contains those prepetition executory contracts and unexpired leases which the Debtors will assume on the Effective Date pursuant to section 8.2 of the Plan and section 365 of the Bankruptcy Code. Schedule 8.2(a) does not contain executory contracts or unexpired leases which have already been assumed pursuant to orders of the Bankruptcy Court or contracts which were entered into by the Debtors after the Petition Date. In addition, the Debtors may seek to assume or reject executory contracts or unexpired leases pursuant to a motion or motions filed prior to the Effective Date. The Debtors, in consultation with the Creditors' Committee, reserve the right to amend Schedule 8.2(a) prior to the Effective Date.

The Debtors' executory contracts and unexpired leases may be loosely divided into three types: (i) programming agreements, (ii) retransmission consents and (iii) other contracts and leases. For ease of reference, the Debtors have divided Schedule 8.2(a) into subschedules, as follows:

Schedule 8.2(a)(i) – General Executory Contracts and Unexpired Leases of the PBT Debtors;

Schedule 8.2(a)(ii) – General Executory Contracts and Unexpired Leases of PST;

Schedule 8.2(a)(iii) – General Executory Contracts and Unexpired Leases of PMC;

Schedule 8.2(a)(iv) – General Executory Contracts and Unexpired Leases of PSC;

Schedule 8.2(a)(v) – Programming Agreements; and

Schedule 8.2(a)(vi) – Retransmission Consents

Each subschedule is organized first by the non-Debtor contracting party, then by the Debtor signatory to the particular executory contract or unexpired lease. Due to the nature of the Debtors' broadcast business, some agreements were entered into by stations identified only by their call letters and/or channel number. Since PBT has the right to enter into agreements for these stations, either through ownership or contractually through local marketing agreements or similar agreements, the Debtors maintain that these contracts are for the benefit of PBT and the relevant executory contracts and unexpired leases are identified with reference to "Pegasus Broadcast Television, Inc." followed by the call letters of the relevant station.

The Debtors' right to enter into agreements extends to certain non-Debtor affiliates, including WFXU Corporation, WFXU License Corporation, WGFL Corporation and WGFL License Corporation, and certain stations owned by KB Prime Media LLC, including WPME (Lewiston, ME), WSWB (Scranton, PA) and WTLF-DT (Tallahassee, FL). Although neither the Plan nor the Bankruptcy Code will affect contracts with these non-Debtor parties in

any way, due to the beneficial relationship described in the preceding paragraph and out of an abundance of caution, the Debtors have chosen to include contracts related to such parties on Schedule 8.2(a).

Schedule 8.2(a) lists the cure amounts the Debtors believe they must pay in order to assume such contracts pursuant to section 365 of the Bankruptcy Code. **Pursuant to section 8.2(b) of the Plan, if you disagree with the cure amount listed for a contract to which you are a party, you must file an objection with the Bankruptcy Court prior to the Confirmation Hearing (currently scheduled for March 24, 2005 at 10:30 a.m.) or be forever barred from asserting any additional or other amounts against the Debtors respecting such cure amount.**
