**ORDER GRANTING THE DEBTORS' THIRD OMNIBUS OBJECTION TO AND
MOTION TO RECLASSIFY, REDUCE OR DISALLOW CERTAIN CLAIMS
PURSUANT TO 11 U.S.C. § 502(b), BANKRUPTCY RULES 3001 AND 3007, AND D.
ME. LBR 3007-1 AND SETTING FORTH THE TREATMENT OF CONTINUED
OBJECTIONS FROM THE DEBTORS' FIRST OMNIBUS OBJECTION TO AND
MOTION TO RECLASSIFY, REDUCE, OR DISALLOW CERTAIN CLAIMS
PURSUANT TO 11 U.S.C. § 502(b) AND BANKRUPTCY RULE 3007**

Upon consideration of the Third Omnibus Objection to and Motion to Reclassify, Reduce or Disallow Certain Claims Pursuant to 11 U.S.C. § 502(b), Bankruptcy Rule 3001 and 3007, and D. Me. LBR 3007-1 (the "Third Omnibus Objection")¹ of Pegasus Satellite Television, Inc. and its subsidiaries and certain of its affiliates, each a debtor and debtor-in-possession herein (collectively, the "Debtors"),² pursuant to which the Debtors requested the entry of an order reclassifying, reducing or disallowing the claims listed in Exhibits A through G to the Third Omnibus Objection as set forth therein; and upon consideration of the Third Omnibus Objection and all pleadings related thereto, including the Amended Notice of Agenda of Matters Scheduled for Hearing on March 24, 2005 at 10:30 A.M., filed on March 23, 2005 (the "Amended Agenda") setting forth the status of all objections from both the Third Omnibus

Objection and all continued objections from the Debtors' First and Second Omnibus Objection to and Motion to Reclassify, Reduce, or Disallow Certain Claims Pursuant to 11 U.S.C. § 502(b) and Bankruptcy Rule 3007 [Docket Nos. 857 and 923] (collectively, the "Continued Objections"), and upon consideration of the statements of counsel made at the hearing with respect to the Third Omnibus Objection and the Continued Objections (the "Hearing"); and the Court finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and (c) notice of the Third Omnibus Objection was due and proper under the circumstances; and it appearing that the relief requested in the Third Omnibus Objection as well as the proposed treatment of the Continued Objections is in the best interests of the Debtors, their estates and creditors; and good and sufficient cause appearing therefor; it is hereby

ORDERED, that the relief requested in the Third Omnibus Objection is granted, and the proposed treatment of the Continued Objections is approved, as set forth herein; and it is further

ORDERED, that each of the Late Filed Claims listed on Exhibit A to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Amended Claims listed on Exhibit B to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Duplicate Claims listed on Exhibit C to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Disputed Amount Claim as listed on Exhibit D to this Order is reduced and allowed in the amount set forth under the column heading “Modified Claim Amount,” as set forth on Exhibit D; and is further

ORDERED, that each No Liability Claim listed on Exhibit E to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Multi-Debtor Claim listed under the column heading “Multi-Debtor Claim be Expunged” on Exhibit F to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Incorrect Debtor Claim listed as “Incorrect Debtor Claims to be Reclassified” on Exhibit G to this Order is hereby reclassified as set forth on Exhibit G; and it is further

ORDERED, that each Claim listed on Exhibit H to this Order as one of the “Previously Filed Claim Objections to be Withdrawn” has been withdrawn from the Third Omnibus Objection; and it is further

ORDERED, that for each claim listed on Exhibit I to this Order, the preliminary hearing as provided for pursuant to D. Me. LBR 3007-1 is continued until April 28, 2005 at 10:30 a.m.; and it is further

ORDERED, that for each claim listed on Exhibit J to this Order, the procedures and dates agreed upon or otherwise established at the Hearing, including, without limitation, discovery procedures, are hereby approved in their entirety and shall govern the pre-trial proceedings with respect to such claims; and it is further

ORDERED, that for each of the Continued Objections, the treatment as set forth on Exhibit K to this Order is approved; and it is further

ORDERED, that Claim No. 567, filed by Collectech Systems, Inc., shall be allowed as an unsecured, non-priority claim in the amount of \$143,499.40; and it is further

ORDERED, that the Debtors and the Clerk of this Court are authorized to take all actions necessary or appropriate to give effect to this Order; and it is further

ORDERED, that the relief granted herein shall be without prejudice to any party in interest's right to (i) object to any claims, including, without limitation, those that have been continued or withdrawn, on any grounds, (ii) renew any objection, on the grounds set forth in any objection, to any and all objections that have been continued or withdrawn, or (iii) object on any grounds to any and all other claims filed against the Debtors and their estates in these chapter 11 cases; and it is further

ORDERED, that this Court shall retain jurisdiction to hear and determine all matters arising from and related to the implementation of this Order.
