Pursuant to this Court’s Order Under 11 U.S.C. §§ 331 and 105(a) Establishing Procedures for Interim Compensation and Reimbursement Expenses for Professionals (the “Interim Procedures Order”) [Docket No. 217] entered on June 24, 2004, objections to the C&TA Monthly Fee Statement were to be filed and served twenty (20) days after the filing and service of the C&TA Monthly Fee Statement. That response deadline was March 30, 2005.

Pursuant to the Interim Procedures Order, C&TA is entitled to payment of \$135,000.00, which represents 90% of the fees (\$135,000.00) requested in the C&TA Monthly Statement for the period January 1, 2005 through January 31, 2005, upon the filing of this Certificate and without the need for

entry of a separate Court order approving the C&TA Monthly Statement. The Debtors are authorized to pay C&TA the sum of 135,000.00.
