#### MOTION FOR ORDER AUTHORIZING THE ASSUMPTION OR ASSUMPTION AND ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES

Pegasus Satellite Television, Inc. and its subsidiaries and certain of its affiliates, each a debtor and debtor-in-possession herein (collectively, the "<u>Debtors</u>"), hereby file this motion (the "<u>Motion</u>") pursuant to sections 105(a) and 365 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") and Rule 6006 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>") for an order authorizing the assumption or the assumption and assignment of certain executory contracts and unexpired leases. In support of the Motion, the Debtors respectfully represent as follows:

The Debtors are: Argos Support Services Company, Bride Communications, Inc., B.T. Broadcast, Inc., Carr Rural TV, Inc., DBS Tele-Venture, Inc., Digital Television Services of Indiana, LLC, DTS Management, LLC, Golden Sky DBS, Inc., Golden Sky Holdings, Inc., Golden Sky Systems, Inc., Henry County MRTV, Inc., HMW, Inc., Pegasus Broadcast Associates, L.P., Pegasus Broadcast Television, Inc., Pegasus Broadcast Towers, Inc., Pegasus Media & Communications, Inc., Pegasus Satellite Television, Inc., Portland Broadcasting, Inc., Primewatch, Inc., PST Holdings, Inc., South Plains DBS, LP., Telecast of Florida, Inc., WDSI License Corp., WILF, Inc., WOLF License Corp., and WTLH License Corp.

#### **JURISDICTION**

- 1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory predicates for the relief sought herein are sections 105(a) and 365 of the Bankruptcy Code and Rule 6006 of the Bankruptcy Rules.

#### BACKGROUND TO THE RELIEF REQUESTED

#### A. <u>Overview</u>

- 3. As of the Petition Date, the Debtors' principal operating business was their direct broadcast satellite ("DBS") business. At that time, the Debtors were the largest independent distributor of DIRECTV ® DBS services with approximately 1.1 million subscribers and the exclusive right to distribute certain DIRECTV services to approximately 8.4 million rural households in certain territories within 41 states.
- 4. In addition to their DBS business, the Debtors (through the Broadcast Debtors<sup>2</sup>) own and operate six broadcast television stations. Additionally, the Debtors have the contractual right to act as the advertising sales agent for one cable television station, as well as the right to control the programming and operate an additional three television stations owned by KB Prime Media LLC ("KB Prime") and one additional station owned by an indirect non-Debtor subsidiary of Pegasus Communications Corporation ("PCC"), the non-debtor parent of PSC.

The Broadcast Debtors are: Pegasus Satellite Communications, Inc., Bride Communications, Inc., BT Satellite Inc., HMW, Inc., Pegasus Broadcast Associates, L.P., Pegasus Broadcast Television, Inc., Pegasus Broadcast Towers, Inc., Portland Broadcasting, Inc., Telecast of Florida, Inc., WDSI License Corp., WILF, Inc., WOLF License Corp., and WTLH License Corp.

#### B. The Chapter 11 Cases

- 5. On June 2, 2004 (the "Petition Date"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. On the Petition Date, the Debtors also jointly filed motions or applications seeking certain typical "first day" orders, including an order to have these cases jointly administered.
- 6. The Debtors are continuing in possession of their properties and are operating and maintaining their businesses as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 7. On June 10, 2004, the United States Trustee for the District of Maine appointed the Official Committee of Unsecured Creditors (the "Committee") pursuant to section 1102(a) of the Bankruptcy Code. No request has been made for the appointment of a trustee or examiner in these cases.
- 8. On January 31, 2005, the Debtors filed the Debtors' First Amended Joint Chapter 11 Plan (the "Plan")<sup>3</sup> and accompanying First Amended Disclosure Statement for the Debtors' First Amended Joint Chapter 11 Plan (the "Disclosure Statement"), each dated January 31, 2005. By orders dated February 9, 2005 (collectively, the "Orders"), the Court, among other things, approved the Disclosure Statement and set the hearing on confirmation of the Plan for March 24, 2005 at 10:30 a.m. (Eastern Standard Time).
- 9. The hearing on confirmation of the Plan has been continued from time to time, including to April 14, 2005, at 10:30 a.m. (Eastern Daylight Time).

#### C. The Broadcast Assets and Broadcast Business

10. In addition to the net proceeds from the sale of the DBS business to DIRECTV, the assets related to the Debtors' broadcast television business (the "Broadcast Assets")

comprise substantially all of the Debtors' remaining assets. The Broadcast Assets are necessary to the operation of the Debtors' broadcast television business, and include, but are not limited to, certain Federal Communications Commission ("FCC") authorizations and licenses, real property, agreements to operate television stations, rights to purchase television stations, time brokerage agreements, lease agreements with respect to studio facilities and other contract rights and working capital.

- 11. The Broadcast Assets also include PSC's rights under an option agreement with KB Prime to acquire, *inter alia*, the licenses of the television stations currently owned by KB Prime but programmed by the Broadcast Debtors, and to acquire rights with respect to a construction permit and construction applications for additional television stations. PSC has exercised its option rights with respect to certain of those assets, resulting in asset purchase agreements that are included in the Broadcast Assets.<sup>4</sup>
- 12. The stations owned or programmed by the Broadcast Debtors are affiliated with the CBS, FOX, UPN and WB networks, and reach approximately 2% of the U.S. television households in five designated market areas ("DMAs"): Wilkes Barre-Scranton, Pennsylvania; Portland, Maine; Chattanooga, Tennessee; Tallahassee, Florida; and Gainesville, Florida. The Broadcast Debtors operate multiple television stations in all of these DMAs except Chattanooga, Tennessee. By combining the operation of two or more television stations in a single DMA, the

Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Plan.

PSC has exercised an option to purchase the WPME license (Portland, Maine) for approximately \$3.9 million and the WSWB license (Wilkes Barre-Scranton, Pennsylvania) for approximately \$2.1 million from their current owner, KB Prime. PSC has similarly exercised an option to acquire a construction permit for Hammond, Louisiana ("Hammond") from KB Prime for approximately \$1.5 million. Both the WPME and Hammond transactions have been approved by the FCC, but not yet consummated. The transfer of the WSWB license remains subject to FCC approval. In addition, PSC holds an option to acquire any or all of the assets of KB Prime, including the license for WTLF-DT (Tallahassee, Florida), the transfer of which would be subject to FCC approval.

Debtors believe they realize substantial revenue and cost synergies, especially with respect to consolidating advertising sales forces, backroom operations and facilities engineers.

#### D. The Liquidating Trustee's Sale of the Broadcast Assets

- 13. The Plan, as amended by the Debtors' proposed Confirmation Order, provides that during the period from the Confirmation Date through the sale or other disposition of the Broadcast Assets, but subject to the occurrence of the Effective Date, the Liquidating Trustee will make all operating decisions and will exercise all control over the Broadcast Assets including the Debtors' broadcast television stations, subject to the jurisdiction of the Bankruptcy Court. It is anticipated that the Liquidating Trustee will be Ocean Ridge Capital Advisors, LLC, a limited liability company whose managing member and sole officer and director is Bradley E. Scher.
- 14. FCC approval is required for the transfer of control over the Broadcast Assets to the Liquidating Trust. On April 8, 2005, the Debtors sought FCC approval by filing "pro forma" applications on FCC form 316 (the "316 Applications").
- that the Bankruptcy Court's continued supervision over the Liquidating Trustee's disposition of the Broadcast Assets is an express condition to FCC approval of the 316 Applications. Accordingly, each 316 Application states that (a) the Liquidating Trustee's operation of the PBT Debtors' business shall remain subject to the jurisdiction of the Bankruptcy Court, and that any disposition of the Broadcast Assets will be subject to Bankruptcy Court approval; and (b) the Confirmation Order shall provide that the Bankruptcy Court retains jurisdiction to enter orders regarding the Liquidating Trustee's operation of the Broadcast Assets and requires the Liquidating Trustee to seek Bankruptcy Court approval under sections 363 and 365 of the Bankruptcy Code for any sale or disposition of all or a portion of the Broadcast Assets.

- 16. The Bankruptcy Court will therefore retain jurisdiction over the actions of the Liquidating Trust and Trustee. The Liquidating Trust will identify a buyer for the Broadcast Assets, seek the required approvals of the Bankruptcy Court, seek the required approvals of the FCC, and take such actions which are necessary to consummate the transfer of the Broadcast Assets to the ultimate buyer.
- 17. The proposed sale of the Broadcast Assets (the "Broadcast Sale") will be the subject of a subsequent motion to be filed with the Court. The Debtors anticipate that the marketing process leading to the Broadcast Sale will either produce a purchaser for the Broadcast Assets (a "Purchaser"),<sup>5</sup> including the Debtors' rights under such executory contracts or unexpired leases as the Purchaser may wish to acquire, or will have clarified which Broadcast Assets, including executory contracts and unexpired leases, have marketable value.

#### E. Assumption and Rejection Provisions of the Plan

- 18. Section 8.1 of the Plan, captioned "Rejection," provides that on the Effective Date, the Debtors shall reject all their executory contracts and unexpired leases except those that
  - (i) are the subject of motions to assume, assume and assign or reject Filed with the Bankruptcy Court and pending on the Confirmation Date for which the Bankruptcy Court shall retain exclusive jurisdiction to determine; (ii) were assumed or rejected before the Confirmation Date; or (iii) are listed on Schedule 8.2(a) of the Plan Supplement.

Plan, § 8.1.

19. Section 8.2 of the Plan, captioned "Assumption," provides, in part, that on the Effective Date, the Debtors will assume the executory contracts and unexpired leases listed on Schedule 8.2(a) and that "the Debtors may also assume, assume and assign or reject certain executory contracts and unexpired leases that are the subject of motions filed with the Bankruptcy

Court and pending on the Confirmation Date for which the Bankruptcy Court shall retain exclusive jurisdiction to determine such motions." Plan, §8.2(a).

20. The Debtors are filing this Motion in an effort to maximize the value of the Broadcast Assets by maintaining the ability to assume or reject contracts to meet the needs of any buyer that may emerge from the marketing thereof.

#### **RELIEF REQUESTED**

- assumption, or assumption and assignment to a Purchaser approved by the Bankruptcy Court, of certain executory contracts and unexpired leases listed on <a href="Exhibit A">Exhibit A</a> attached hereto (respectively the "Assumed Contracts" and the "Assumed Leases"). If a proposed Purchaser has been identified prior to the hearing on this Motion (the "Hearing"), the Assumed Contracts and Assumed Leases will be assumed and assigned to the Purchaser effective as of the closing of the Broadcast Sale (the "Closing Assumption Date"). If there is no proposed Purchaser as of the Hearing, the Assumed Contracts and Assumed Leases will be assumed effective as of the date the order approving this Motion becomes a Final Order (the "Order Assumption Date").
- 22. Exhibit A sets forth the amount the Debtors propose to pay each counterparty to the Assumed Contracts and Assumed Leases as compliance with the cure requirements of section 365 of the Bankruptcy Code (the "Cure Amount"). If any party objects to the Cure Amount for an Assumed Contract or Assumed Lease, or to the assumption or assumption and assignment thereof to the Purchaser, such party must file an objection (an "Assumption Objection") no later than 4:00 p.m. on the date that is seven (7) days prior to the Hearing (the "Objection Deadline"). Each Assumption Objection must:
  - a. be in writing;

- b. state with specificity the grounds for the objection, including, if applicable, the fully liquidated Cure Amount which such party believes is required and the specific types and dates of the alleged defaults, pecuniary losses and conditions giving arise thereto; and
- c. be filed with the Clerk of the Bankruptcy Court and be served so as to be actually received on or before the Objection Deadline by (i) the Liquidating Trustee and (ii) counsel to the Creditors' Committee.
- Objection is received but does not comply with the foregoing requirements, with respect to any Assumed Contract or Assumed Lease: (i) the Debtors shall be authorized to assume or assume and assign to the Purchaser, if and as applicable, such Assumed Contract or Assumed Lease upon the payment of the Cure Amount and the occurrence of the Closing Assumption Date or the Order Assumption Date, as applicable, (ii) the Cure Amount shall be fixed at the amount set forth in Exhibit A, notwithstanding anything to the contrary in any Assumed Contract or Assumed Lease, proof of claim (whether formal or informal) or any other document or instrument, and (iii) the counterparty to such Assumed Contract or Assumed Lease shall be forever barred from asserting any claims arising on or before the Closing Assumption Date or the Order Assumption Date, as applicable, against the Debtors, the Reorganized Debtors, the Liquidating Trustee or a Purchaser approved by the Bankruptcy Court, or their respective successors or assigns, with respect to such Assumed Contract or Assumed Lease.
- 24. The Liquidating Trustee shall pay the Cure Amounts (a) in Cash within forty-five (45) days after the Closing Assumption Date or the Order Assumption Date, as applicable, or (b) on such other terms as may be agreed to by a counterparty to an Assumed Contract or Assumed Lease. If a dispute occurs regarding: (x) the cure amount; (y) the ability of the Reorganized Debtors or the Purchaser to provide adequate assurance of future performance under the Assumed Contract or Assumed Lease; or (z) any other matter pertaining to assumption, then the Cure Amounts shall be paid following entry of a Final Order resolving the dispute and approving assumption. The

Reorganized Debtors shall retain the right to reject any executory contract or unexpired lease that is subject to a dispute concerning a Cure Amount until thirty (30) days following entry of a Final Order resolving such dispute.

- 25. The Debtors reserve the right, on behalf of the Reorganized Debtors and the Liquidating Trustee, to modify Exhibit A, upon notice to the parties to any Assumed Contract or Assumed Lease affected by such amendment, no later than the date that is ten (10) days prior to the Hearing. Any Assumed Contract or Assumed Lease that is removed from Exhibit A pursuant to such an amendment shall be deemed rejected upon the occurrence of the Closing Assumption Date or the Order Assumption Date.
- 26. The Debtors also reserve the right, on behalf of the Reorganized Debtors and the Liquidating Trustee, to seek authorization to assume or to assume and assign any Assumed Contract or Assumed Lease prior to the Hearing. Such assumption or assumption and assignment shall be made pursuant to the terms of an order of the Bankruptcy Court granting such authorization.

#### **APPLICABLE LAW**

#### Post-Confirmation Jurisdiction

"assume, assume and assign or reject certain executory contracts and unexpired leases that are the subject of motions Filed with the Bankruptcy Court and pending on the Confirmation Date for which the Bankruptcy Court shall retain exclusive jurisdiction." The Debtors therefore file this Motion in compliance with the Plan and to support the Bankruptcy Court's retention of jurisdiction with respect to the Broadcast Sale and consequent assumption and assignment of the Assumed Contracts and Assumed Leases.

- 28. This Court retains jurisdiction over the post-confirmation sale of the Broadcast Assets and the assumption or assumption and assignment of the Assumed Contracts and Assumed Leases pursuant to the Bankruptcy Code and section 13.1 of the Plan. Section 1142(b) of the Bankruptcy Code provides that a bankruptcy court retains jurisdiction to ensure that the terms and provisions of a confirmed chapter 11 plan are carried out. See In re Johns-Manville Corp., 97 Bankr. 174, 180 (Bankr. S.D.N.Y. 1989) (clear intent of section 1142(b) is to assure that the terms and provisions of a confirmed chapter 11 plan are carried out until the plan is completed and the case is closed). More specifically, prior cases have held that the bankruptcy court retains jurisdiction to approve the sale of a debtor's assets, and that such retention is particularly appropriate where, as here, the Plan expressly provides for the court's continued jurisdiction. See, e.g., In re Bicoastal Corp., 164 B.R. 1009 (Bankr. M.D. Fl. 1993); see also In re Chateaugay Corp., 201 B.R. 48, 66 (Bankr. S.D.N.Y. 1996). Accordingly, this Court retains jurisdiction to approve any post-confirmation sale of the Broadcast Assets, including the necessary assumption or assumption and assignment to the Purchaser of the Assumed Contracts and Assumed Leases. Assumption and Assignment of Certain Executory Contracts and Unexpired Leases
- 29. In order to maximize the marketable value of the Broadcast Assets, the Debtors seek authority to assume or assume and assign to a Purchaser the Assumed Contracts and Assumed Leases. Section 365 of the Bankruptcy Code authorizes a debtor to assume, or assume and assign its executory contracts and unexpired leases at the request of a successful bidder, subject to the approval of the Bankruptcy Court, provided that the defaults under such contracts and leases are cured and adequate assurance of future performance is provided.
- 30. The meaning of "adequate assurance of future performance" depends on the facts and circumstances of each case, but should be given "practical, pragmatic construction." <u>See Carlisle Homes, Inc. v. Arrari (In re Carlisle Homes, Inc.)</u>, 103 B.R. 524, 538 (Bankr. D.N.J. 1988).

Among other things, adequate assurance may be given by demonstrating an assignee's financial health and experience in managing the type of enterprise or property assigned. In re Bygaph, Inc., 56 B.R. 596, 605-06 (Bankr. S.D.N.Y. 1986) (adequate assurance of future performance is present when prospective assignee of a lease has financial resources and has expressed a willingness to devote sufficient funding to business in order to give it strong likelihood of succeeding). As part of the marketing of the Broadcast Assets pursuant to this requirement, the Debtors, the Creditors' Committee and/or the Liquidating Trustee, as applicable, will evaluate the financial wherewithal of all potential bidders before qualifying such bidders as a potential Purchaser. The Debtors themselves have been materially performing their postpetition obligations under the Assumed Contracts and Assumed Leases.

- lease must satisfy the "business judgment rule" and should not be subject to review unless such decision is clearly an unreasonable exercise of such judgment. Group of Institutional Investors v. Chicago, Milwaukee, St. Paul & Pacific Ry. Co., 318 U.S. 523 (1943) (rejecting the test of whether the executory contract was burdensome in favor of whether rejection is within the debtor's business judgment); In re Lubrizol, 756 F.2d at 1046-47. If a debtor's business judgment has been reasonably exercised, a court should approve the assumption or rejection of the unexpired contract. Butler v. Resident Care Innovation Corp., 241 B.R. 37, 45-46 (D.R.I. 199); In re Logical Software, Inc., 66 B.R. 683, 686-87 (Bankr. D. Mass. 1986).
- 32. The Debtors will demonstrate that all requirements for assumption or assumption and assignment of the Assumed Contracts and Assumed Leases will be satisfied. The Debtors anticipate that the Broadcast Sale will proceed with the approval of the Bankruptcy Court pursuant to section 363 of the Bankruptcy Court in the near future. The Debtors believe that their rights under the Assumed Contracts and Assumed Leases are vital assets of the Debtors, but

recognize that potential Purchasers may have differing requirements based on their own resources and business models. The Debtors also believe, in exercising their sound business judgment, that retaining the ability to assume or assume and assign the Assumed Contracts and Assumed Leases will greatly facilitate the sale of the Broadcast Assets for the highest possible price. The Debtors therefore respectfully submit that this Court should approve the assumption or assumption and assignment of the Assumed Contracts and Assumed Leases to as provided herein.

#### **NO PRIOR REQUEST**

33. No prior motion for the relief requested herein has been made to this or any other court.

#### **NOTICE**

34. Notice of this Motion has been provided to: (i) all parties on the All Notices
List as required by (and as defined in) this Court's Order Establishing Case Management
Procedures and Hearing Schedule, dated July 9, 2004; and (ii) each party to the Assumed Contracts
and Assumed Leases listed in Exhibit A.

#### **WHEREFORE**, the Debtors respectfully request that the Court grant this Motion

and such other and further relief as is necessary or proper.
