The undersigned, on behalf of Akin Gump Strauss Hauer & Feld LLP (“Akin”) hereby certifies that, as of the date hereof, he has received no answer, objection or other responsive pleading to the Statement of Fees for Services Rendered and Out-of-Pocket Expenses as Co-Counsel to the Official Committee of Unsecured Creditors for the Period Beginning February 1, 2005 and Ending February 28, 2005 (the “Akin Monthly Fee Statement”) [Docket No. 1160], which was filed on March 28, 2005. The undersigned further certifies that he has caused the Court’s docket in this case to be reviewed and no answer, objection or other responsive pleading to the Akin Monthly Fee Statement appears thereon. Pursuant to this Court’s Order Under 11 U.S.C. §§ 331 and 105(a) Establishing Procedures for Interim Compensation and Reimbursement Expenses for Professionals (the “Interim Procedures Order”) [Docket No. 217] entered on June 24, 2004, objections to the Akin Monthly Fee Statement were to be filed and served twenty (20) days after the filing and service of the Akin Monthly Fee Statement. That response deadline was April 18, 2005.

Pursuant to the Interim Procedures Order, Akin is entitled to payment of (i) \$309,064.50, which represents 90% of the fees (\$343,405.00) and (ii) \$16,508.51, which represents 100% of the expenses, requested in the Akin Monthly Fee Statement for the period February 1, 2005 through February 28, 2005,

upon the filing of this Certificate and without the need for entry of a separate Court order approving the Akin Monthly Statement. The Debtors are authorized to pay Akin the sum of \$325,573.01
