ORDER GRANTING THE DEBTORS' FOURTH OMNIBUS OBJECTION TO AND MOTION TO RECLASSIFY, REDUCE OR DISALLOW CERTAIN CLAIMS PURSUANT TO 11 U.S.C. § 502(b), BANKRUPTCY RULES 3001 AND 3007, AND D. ME. LBR 3007-1

Upon consideration of the Debtors' Fourth Omnibus Objection to and Motion to Reclassify, Reduce or Disallow Certain Claims Pursuant to 11 U.S.C. § 502(b), Bankruptcy Rules 3001 and 3007, and D. Me. LBR 3007-1 (the "Fourth Objection")¹ of Pegasus Satellite Television, Inc. and its subsidiaries and certain of its affiliates, each a debtor and debtor-in-possession herein (collectively, the "Debtors"),² pursuant to which the Debtors requested the entry of an order reclassifying, reducing or disallowing the claims listed in Exhibits A through F to the Fourth Objection and one additional claim specifically identified in the Fourth Objection as set forth therein; and upon consideration of the Fourth Objection and all pleadings related thereto, including the Amended Notice of Agenda of Matters Scheduled for Hearing on April 28, 2005 at 10:30 A.M., filed on April 27, 2005 (the "Amended Agenda") setting forth the status of all objections from both the Fourth Objection and all continued objections from the Debtors'

First, Second and Third Omnibus Objection to and Motion to Reclassify, Reduce, or Disallow Certain Claims Pursuant to 11 U.S.C. § 502(b) and Bankruptcy Rule 3007 [Docket Nos. 857, 923 and 1017] (collectively, the "Continued Objections"), and upon consideration of the statements of counsel made at the hearing with respect to the Fourth Objection and the Continued Objections; and the Court finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and (c) notice of the Fourth Objection was due and proper under the circumstances; and it appearing that the relief requested in the Fourth Objection as well as the proposed treatment of the Continued Objections is in the best interests of the Debtors, their estates and creditors; and good and sufficient cause appearing therefor; it is hereby

ORDERED, that the relief requested in the Fourth Objection is granted, and the proposed treatment of the Continued Objections is approved, as set forth herein; and it is further

ORDERED, that each of the Late Filed Claims listed on Exhibit A to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Amended Claims listed on Exhibit B to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Duplicate Claims listed on Exhibit C to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each No Liability Claim listed on <u>Exhibit D</u> to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Claim to be Reclassified listed on Exhibit E to this Order is hereby Reclassified to the priority status set forth under the column heading "Modified Claim Priority Status," as set forth on Exhibit E; and it is further

ORDERED, that for each claim listed on Exhibit F to this Order, the preliminary hearing as provided for pursuant to D. Me. LBR 3007-1 is continued until May 20, 2005 at 10:30 a.m.; and it is further

ORDERED, that for each of the Continued Objections, the treatment set forth on Exhibit G to this Order is approved, and it is further

ORDERED, that the Georgia Claim, Claim No. 1097, is hereby disallowed to the extent it seeks to recover for pre-petition liabilities of the Debtors, and the Debtors reserve their rights to object to the remaining \$16,430 requested in the Georgia Claim which relates to alleged post petition liabilities of the Debtors on any grounds in the future; and it is further

ORDERED, that the claim filed with the Bankruptcy Court by R.F. Media
Associates ("RF Media") and time stamped April 21, 2005 at 12:46 by the Bankruptcy Court,
Claim Number 1118, (the "Remaining RF Media Claim") shall be allowed in the amount of
\$189,258.00 (the "Agreed Amount"), although the Debtors expressly reserve their rights to
object to the priority status of the Remaining RF Media Claim in the future and to assert that
such claim should be reclassified to an unsecured, non-priority claim in the Agreed Amount.
There shall not be any objections to the Remaining RF Media Claim other than as stated herein.
Regardless of whether the Remaining RF Media Claim is allowed as secured or unsecured, it
shall be allowed in the bankruptcy cases of the PBT Debtors (as that term is defined in the
debtors' bankruptcy plan existing as of the date hereof). Per agreement of the parties, Claim

Nos. 1079 and 1094 are hereby disallowed and expunged in their entirety. Additionally, per agreement of the parties, Claims 298 and 874, filed by Citadel Broadcasting Company ("Citadel"), Claim No. 883 filed by Citadel Broadcasting of Chattanooga ("Citadel Broadcasting"), and Claim No. 210 filed by Entercom Wilkes Barre Scranton, LLC ("Entercom") respectively, are hereby disallowed and expunged in their entirety; and it is further

ORDERED, that per the agreement of the parties, the resolution above with respect to RF Media, Citadel, Citadel Broadcasting and Entercom resolves any and all prepetition claims or liabilities owed to such parties from the Debtors, or the Debtors' officers, directors, partners, joint venturers, employers, employees, agents stockholders, attorneys, predecessors, successors, parent companies, affiliates, assigns and personal representatives, individually and collectively; and it is further

ORDERED, that the Debtors and the Clerk of this Court are authorized to take all actions necessary or appropriate to give effect to this Order; and it is further

ORDERED, that the relief granted herein shall be without prejudice to any party in interest's right to (i) object to any claims, including, without limitation, those that have been continued or withdrawn, on any grounds, (ii) renew any objection, on the grounds set forth in any objection, to any and all objections that have been continued or withdrawn, or (iii) object on any grounds to any and all other claims filed against the Debtors and their estates in these chapter 11 cases; and it is further

ORDERED, that this Court shall retain jurisdiction to hear and determine all matters arising from and related to the implementation of this Order.
