UNITED STATES TRUSTEE’S *CONSENTED TO*
MOTION TO EXTEND DEADLINE FOR OBJECTING TO
THIRD AND FINAL FEE APPLICATION FILED BY
AKIN GUMP STRAUSS HAUER & FELD, CO-COUNSEL TO
THE OFFICIAL UNSECURED CREDITORS’ COMMITTEE
(WITH CERTIFICATE OF SERVICE)

Pursuant to 28 U.S.C. § 586(a)(3)(A), 11 U.S.C. §§ 307, 328(c), 330, 331 and 1103(b), Fed. R. Bankr. P. 2014 and 2016 and Me. L. B. R. 2014-1 and 2016-1, the United States Trustee moves the Court to extend until close of business on Tuesday, July 12, 2005 the deadline for objecting to the third and final fee application (“Fee Application”) (Docket #1494) submitted by Akin Gump Strauss Hauer & Feld (“Akin Gump”), counsel to the official unsecured creditors’ committee of Pegasus Satellite Television, Inc., *et al.* Akin Gump, through its counsel, David Botter, Esq., has consented to the requested extension.

In support, the United States Trustee says:

1. The Court has established July 11, 2005 as the deadline by which parties in interest, including the United States Trustee, must object to the Fee Application.
2. The United States Trustee has transmitted a draft objection to the Fee Application to Akin Gump. The parties have discussed it.

3. The United States Trustee needs additional time to analyze Akin Gump's response.

4. Akin Gump has consented to the requested extension.

WHEREFORE, the United States Trustee prays that the Court enter orders: i) extending the deadline to object to the Fee Application until close of business on Tuesday, July 12, 2005; and ii) granting her such other and further legal and equitable relief to which she may be entitled.
