**AGREED-UPON MOTION FOR AMENDED ORDER GRANTING THE SEVENTH  
OMNIBUS  
OBJECTION TO AND MOTION TO DISALLOW OR  
RECLASSIFY CERTAIN CLAIMS PURSUANT TO 11 U.S.C.  
§ 502(b), BANKRUPTCY RULE 3007, AND D. ME. LBR 3007-1**

The Liquidating Trustee of the PSC Liquidating Trust, on behalf of the Reorganized Debtors, and with the consent of the United States Department of Treasury, moves to amend the previously entered Order Granting the Seventh Omnibus Objection [Docket No. 1792] because of a clerical error. At the hearing on the Seventh Omnibus Objection, counsel for the Liquidating Trustee and counsel for the Department of the Treasury put on the record that an agreement had been reached to withdraw the objection as it may have related to the claims of the Department of the Treasury, and to set January 15, 2006, as a new deadline for objection to the claims of the Department of Treasury.

The parties have realized, however, that the exhibits to the order entered continued to reference the Department of Treasury claims, and that there was no language in the Order as entered reflecting the agreement placed on the record. Accordingly, the Liquidating Trustee and the Department of Treasury, whose counsel has reviewed the attached proposed order, submit an amended order to correct this error. The amended order differs from the original order only in

adding a second to last paragraph that clearly references the agreement with the Department of Treasury.

WHEREFORE, the Liquidating Trustee, with the consent of the Department of Treasury, and pursuant to Bankruptcy Rule 9024, incorporating Fed. R. Civ. P. 60(a), requests entry of the attached amended order to correct the error recently discovered, and such other, further relief as the Court deems just.
