That response deadline was July 19, 2004.

Pursuant to the Interim Procedures Order, PA is entitled to payment of \$11,478.21 which represents 90% of the fees (\$10,699.20) and \$809.01, which represents 100% of the expenses, requested in the PA Monthly Statement for the period June 2, 2004 through June 30, 2004, upon the filing of this Certificate and without the need for entry of a separate Court order approving the PA Monthly Statement. The Debtors are authorized to pay PA the sum of \$11,478.21.
