**ORDER DIRECTING  
JOINT ADMINISTRATION OF CHAPTER 11 CASES**

Upon consideration of the motion of HMW, Inc. a Maine corporation (“HMW”), and certain affiliates of HMW, each a debtor and debtor in possession herein (collectively, the “Debtors”) filed on June 2, 2004 for entry of an order pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure, directing the joint administration of the above-captioned cases under chapter 11 of title 11 of the United States Code; and it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, and that this is a core proceeding pursuant to 28 U.S.C. §§ 157(b)(2); and upon the Affidavit of Ted S. Lodge,

President, Chief Operating Officer and Counsel of Pegasus Satellite Communications, Inc., in Support of First Day Motions; and it appearing that joint administration of these cases is in the best interests of the Debtors and their respective estates and creditors; and notice of the Motion has been given to (i) the United States Trustee for the District of Maine; (ii) the Debtors' fifty (50) largest unsecured creditors on a consolidated basis, as identified in their chapter 11 petitions; (iii) the administrative agents for the credit facilities of Pegasus Media & Communications, Inc. and Pegasus Satellite Communications, Inc. ("PSC") and (iv) each of the indenture trustees for each series of notes of PSC; and it appearing that no other notice need be given; after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED, that these cases shall be jointly administered by this Court and by the Office of the United States Trustee; and it is further

ORDERED, that the form of consolidated caption for these cases is hereby approved in the following form:
