HELEN E. D'ANTONA, being duly sworn, deposes and says,

- 1. I am the Manager of Litigation Support Services for Viacom Inc. ("Viacom"). King World Productions, Inc. ("King World") is a subsidiary of Viacom. I submit this Affidavit in opposition to the Debtor's First Omnibus Objection To and Motion to Reclassify, Reduce or Disallow Certain Claims Pursuant to 11 U.S.C. § 502 (b), Bankruptcy Rules 3001 and 3007, and D.ME LBR 3007-1. ("the Motion").
- 2. My job responsibilities include handling bankruptcy matters. Consequently, bankruptcy notices sent to King World or other Viacom subsidiaries are forwarded to me for processing and handling.
- 3. On or about October 8, 2004, Viacom timely filed, on behalf of King World, four proofs of claim against various debtors for \$73,489.00 in the captioned bankruptcy. (Copies of the proofs of claim are attached as Exhibit A.)
 - 4. On or about December 23, 2004, the Motion was

served on King World.

- 5. In the Motion (Pages 11-12, Paragraphs 28-30), the Debtor requests that the Court agree to expunge King World's Claim Nos. 509, 510 and 511 leaving Claim No. 508 against Debtor Pegasus Broadcast Television, Inc. King World admits that it filed multiple proofs of claim. It did so because it was unsure as to which debtor to assert its claim and because it wanted to preserve its rights. King World has no objection to the expunging of Claim Nos. 509, 510 and 511 providing that Claim No. 508 in the amount of \$73,489.00 be allowed to stand. Debtors also allege that "according to the Debtors' books and records", the correct amount owed to King World is \$11,151.06 and request that the Court reduce the claim to that amount. (Motion, Page 10, Paragraph 24).
- 6. King World seeks recovery for programming licensed to the Debtor. An open receivables report indicating invoice numbers and dates, contracts numbers and amounts due for the programming licensed to the debtor is attached to King World's proofs of claim. (See Proofs of Claim attached hereto as Exhibit A).
- 7. King World does not seek to enrich itself unjustly as to the Debtors' other creditors. King World seeks what is fairly owed to it for the licensing services it provided to the Debtor.
- 8. Additionally, to the extent there is any other reason for seeking to disallow and/or expunge King World's claim, King World already has filed a proof of claim with

supporting documents, that evidence the Debtor's liability for the licensing services. (See Proofs of Claim attached hereto at Exhibit A).

9. King World respectfully requests that Claim No. 508 in the amount of \$73,489.00 be allowed to stand for the reasons stated above.
