**ORDER GRANTING THE DEBTORS' FIRST OMNIBUS OBJECTION TO AND MOTION
TO RECLASSIFY, REDUCE OR DISALLOW CERTAIN CLAIMS PURSUANT TO
11 U.S.C. § 502(b), BANKRUPTCY RULES 3001 AND 3007, AND D. ME. LBR 3007-1**

Upon consideration of the Debtors' First Omnibus Objection to and Motion to Reclassify, Reduce or Disallow Certain Claims Pursuant to 11 U.S.C. § 502(b), Bankruptcy Rule 3001 and 3007, and D. Me. LBR 3007-1 (the "Objection"),¹ pursuant to which the Debtors requested the entry of an order (the "Order") reclassifying, reducing or disallowing the claims listed in Exhibits A through G to the Order as set forth herein; and upon consideration of the Objection and all pleadings related thereto, including the statements of counsel made at the hearing thereon; and the Court finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and (c) notice of the Objection was due and proper under the circumstances; and it appearing that the relief requested in the Objection is in the best interests of the Debtors, their estates and creditors; and good and sufficient cause appearing therefor; it is hereby

ORDERED, that the relief requested in the Objection is granted; and it is further

ORDERED, that each of the Late Filed Claims listed on Exhibit A to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Amended Claims listed on Exhibit B to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Duplicate Claims listed on Exhibit C to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each of the Insufficient Documentation Claims listed on Exhibit D to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Disputed Amount Claim as listed on Exhibit E to this Order is reduced and allowed in the amount set forth under the column heading “Modified Claim Amount,” as set forth on Exhibit E; and is further

ORDERED, that each No Liability Claim listed on Exhibit F to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Multi-Debtor Claim listed under the column heading “Multi-Debtor Claim be Expunged” on Exhibit G to this Order is hereby disallowed and expunged in its entirety; and it is further

ORDERED, that each Claim listed on Exhibit H to this Order as one of the “Previously Filed Claim Objections to be Withdrawn” has been withdrawn from the Objection; and it is further

ORDERED, that each Claim listed on Exhibit I to this Order as one of the "Previously Filed Claim Objections to be Continued" has been removed from the Objection, with such objection to such Claim to be continued to a later date; and it is further

ORDERED, that this Order is without prejudice to the Debtors' rights to (a) object to the Disputed Claims, including, without limitation, those that have been continued or withdrawn listed on Exhibits H and I hereto, on any grounds other than as set forth in the Objection, (b) renew any objection, on the grounds set forth in the Objection, to the Disputed Claims set forth on Exhibit I that have been continued, or (c) object on any grounds to any and all other claims filed against the Debtors and their estates in these chapter 11 cases; and it is further

ORDERED, that the Debtors and the Clerk of this Court are authorized to take all actions necessary or appropriate to give effect to this Order; and it is further

ORDERED, that this Court shall retain jurisdiction to hear and determine all matters arising from and related to the implementation of this Order.
