**ONEBEACON'S OBJECTION TO THE MOTION OF QUIGLEY AND PFIZER  
FOR AN ORDER PARTIALLY WITHDRAWING THE REFERENCE TO ENABLE  
THE DISTRICT AND BANKRUPTCY COURTS TO SIT JOINTLY AT THE  
CONFIRMATION HEARING**

OneBeacon America Insurance Company<sup>1</sup> hereby objects to the motion (the "Motion," Dkt. No. 1) of Quigley Company, Inc. (the "Debtor") and Pfizer Inc. (collectively, the "Movants") requesting this Court to partially withdraw the reference of the Debtor's

<sup>1</sup> OneBeacon is a creditor of the estate, having filed a proof of claim against Quigley which have not been objected to. OneBeacon also issued insurance to Pfizer, which Quigley and Pfizer each assert is obligated to provide coverage for asbestos claims.

Chapter 11 case to permit this Court to: (i) preside jointly with the Bankruptcy Court at the confirmation hearing with respect to Debtor's plan of reorganization (the "Plan"); (ii) enter the permanent injunctions under § 524(g) of the Bankruptcy Code in connection with confirmation of the Plan; and (iii) issue or affirm an order confirming the Plan under § 524(g)(3)(A) of the Bankruptcy Code.

As grounds for its objection, OneBeacon incorporates, as though fully stated here, the grounds stated in the objections of the ACE Insurers (Dkt. No. 10), the Hartford Insurers (Dkt. No. 24), and CNA (Dkt. No. 27). OneBeacon also joins in the ACE Insurers' request for oral argument (Dkt. No. 14).

WHEREFORE, OneBeacon objects to the Motion and urges that it be denied.
