**Proceedings:**

Mr. Milmoie urged his motion to amend the bidding procedures to continue the sale to September 10, 2009 and postpone the relocation sale. He stated that he believes everyone is in agreement to sell the team. He noted that the issue involving PSE has been resolved. He confirmed that the NHL would like the Glendale auction date moved to September 10, 2009 and the relocation date be vacated.

The Court asked for opposition to moving the August 5, 2009 Glendale auction date. There were no objections.

Mr. Salerno stated that he has no objection as long as the Glendale auction is held with the relocation sale.

COURT: IT IS ORDERED VACATING THE AUGUST 5, 2009 AUCTION DATE AND RESCHEDULING IT TO SEPTEMBER 10, 2009 AT 9:00 A.M.

Mr. Milmoie discussed with the Court the disposition of the relocation hearing.

Mr. Baldiga responded, stating that this morning he filed papers underseal which are very important.

Mr. Sieger explained his position, stating that he must know by September 10th or they cannot close by September 30, 2009.

Mr. Greenberg stated that he is happy with the extended date and they hope to keep the team in Glendale.

Mr. Sala stated that the committee believes that everything needs to happen at the same time.

Mr. Abramowitz responded, stating that his interest is to be paid in full and has no problem with the September 10, 2009 hearing.

Mr. Salerno replied, stating that both the Glendale and relocation bids should be entertained on September 10, 2009.

Ms. Freeman explained her client's position.

Mr. Milmoie informed the Court that NHL is not processing the relocation part of PSE's bid.
