The National Hockey League (the "NHL" or "League"), through counsel, hereby requests entry of an order setting an accelerated hearing on shortened notice on its Emergency Motion to Authorize Team Management to Enter Into Agreement with US Airways for Team Travel Service ("Emergency Motion").

There has arisen a dispute regarding team flight service for the 2009-2010 NHL season, between team management (specifically, Rick Braunstein who oversees team travel and Don Maloney, the general manager of the Phoenix Coyotes and a Senior Officer) and Mr. Bill Daly, as the NHL's Point Person with respect to certain team management decisions, on the one hand, and Mr. Earl Scudder, the personal attorney for Jerry Moyes and the Debtors' Point Person with respect to certain team management decisions, on the other hand.

The first game of the season is scheduled for October 1, 2009, while the first game of the preseason is set for September 14, 2009. The dispute among the NHL, the team management and Mr. Scudder must be resolved expeditiously in order for the team to take advantage of the price savings offered by US Airways in time for the preseason.

WHEREFORE, the NHL requests entry of an Order setting an accelerated hearing on shortened notice on its Emergency Motion for August 11, 2009 at 1:30 p.m. or such other time as the Court may determine.
