25 The National Hockey League ("NHL" or "League"), through counsel, hereby requests entry of
26 an Order authorizing it to file a redacted version of the NHL's Reply In Support Of Determination That
27 Debtors' NHL Membership Rights May Not Be Transferred To PSE Or An Affiliate Thereof ("NHL
28 Reply") with an unredacted version together with certain exhibits to be filed under seal for the reason

1 that the NHL Reply and certain of the exhibits, contain information which is designated as highly
2 confidential and not to be made public pursuant to the Order Governing the Exchange and Use of
3 Confidential Information (Docket #455). Simultaneously with this Motion, the NHL is delivering a
4 copy of the unredacted version of the NHL Reply to the Court, to counsel for the Debtors, Jerry
5 Moyes, and the City of Glendale, and the Unsecured Creditors Committee and to others who have
6 executed the appropriate confidentiality agreements.

7 **WHEREFORE**, the NHL requests entry of an Order authorizing the filing of a redacted
8 version of the NHL Reply with an unredacted version together with certain exhibits to be filed under
9 seal, conditioned upon the availability of such pleadings to those parties-in-interest executing an
10 appropriate confidentiality agreement, and granting such other relief as is just in the circumstances.
