23 The National Hockey League ("NHL" or "League"), through counsel, hereby requests entry of
24 an Order authorizing it to file a redacted version of certain deposition excerpts with an unredacted
25 version to be filed under seal for the reason that certain portions of the deposition transcripts contain
26 information which is designated as highly confidential and not to be made public pursuant to the Order
27 Governing the Exchange and Use of Confidential Information (Docket #455). Simultaneously with

1 this Motion, the NHL is delivering a copy of the unredacted version of the deposition excerpts to the
2 Court, to counsel for the Debtors, Jerry Moyes, and the City of Glendale, and the Unsecured Creditors
3 Committee and to others who have executed the appropriate confidentiality agreements.
