CHAPTER 7 TRUSTEE'S OBJECTION TO ADMINISTRATIVE CLAIM NO. 728 FILED BY FORSYTH COUNTY WATER AND SEWER DEPARTMENT

COMES NOW Marcus A. Watson, Sr., Chapter 7 Trustee of Pike Nursery Holding, LLC, and objects to administrative claim no. 728 in the amount of \$1,173.65 filed by Forsyth County Water and Sewer Department ("Forsyth") pursuant to 11 U.S.C. § 502 and Fed. Bankr. R. 3007 on the grounds that the claim is untimely. In support of his Objection, the Trustee shows this Court as follows:

1. This bankruptcy case began as a voluntary Chapter 11 petition filed on November 14, 2007.
2. On March 3, 2008, the Court entered a series of orders approving a sale of virtually all of the Debtor's wholesale and retail businesses and related assets. The Debtor thereafter ceased operations.
3. On March 17, 2008, this Court entered an Order Directing the United States Trustee to Appoint Chapter 11 Trustee in this bankruptcy case. On March

19, 2008, the Court approved the United States Trustee's appointment of Marcus A. Watson, Sr. as the Chapter 11 Trustee for the Debtor.

4. On March 24, 2008, the Court converted the case to Chapter 7 and Marcus A. Watson, Sr. was appointed as the interim Chapter 7 Trustee and became the permanent Chapter 7 Trustee after the first meeting of creditors on April 28, 2008.

5. On or about April 3, 2008, the Court entered an Order fixing May 30, 2008 as the deadline for filing of Chapter 11 administrative claims ("Bar Date") [Docket No. 415].

6. On or about April 4, 2008, BMC Group, the Trustee's servicing agent, served Forsyth with a copy of the Bar Order and attached proof of claim form at the following address: P.O. Box 100003, Cumming, Georgia 30028-8303 [Docket No. 435].

7. On March 14, 2011, Forsyth filed an administrative proof of claim on the form provided with the Bar Order, claim no. 728, asserting a Chapter 11 administrative claim in the amount of \$1,173.65.

8. On June 28, 2010, the Trustee filed Chapter 7 Trustee's Motion to Authorize Distribution to Chapter 11 Administrative Claimants seeking authority to pay the Chapter 11 administrative claims. On August 6, 2010, the Court entered

an Order Granting Chapter 7 Trustee's Motion to Authorize Distribution to Chapter 11 Administrative Claimants authorizing the Trustee to pay the Chapter 11 administrative claims.

9. Because the administrative claim was filed over two years after the Bar Date for such claims, the Trustee requests that the Court disallow claim no. 728.

WHEREFORE Marcus A. Watson, Sr., Chapter 7 Trustee of Pike Nursery Holding, LLC, requests that the Court sustain his objection and disallow claim no. 728 as untimely.
