**NOTICE OF HEARING**

PLEASE TAKE NOTICE that the law firm of Scroggins & Williamson (“S&W”), Chapter 11 counsel for the Debtor, has filed the Application of Scroggins & Williamson for Final Compensation and Reimbursement of Expenses (the "S&W Application") seeking final compensation in the amount of \$459,851.00, plus reimbursement of expenses in the amount of \$14,638.55, for the period from November 7, 2007, through and including March 24, 2008.
