ORDER AUTHORIZING THE DEBTOR TO REJECT NON-RESIDENTIAL REAL PROPERTY LEASE (STORE # 49 – STOCKBRIDGE)

This matter is before the Court on the motion of Pike Nursery Holding LLC ("Debtor") for authority to reject, effective as of the Petition Date, a non-residential real property lease between the Debtor and JDN Realty Corporation ("Lessor") for a facility located at 599 Highway 138 West, Stockbridge, Georgia 30281 (the "Lease"). Capitalized terms used but not defined in this Order shall have the meanings ascribed to such terms in the Motion.

The Court has considered the Motion, the Declaration of Scott Schnell in Support of First Day Applications and Motions, and the matters reflected in the record of the hearing held on the Motion. It appears that the Court has jurisdiction over this proceeding; that this is a core proceeding; that notice of the Motion has been given to the Office of the United States Trustee,

counsel for the Debtor's pre-petition senior secured lenders, counsel to the Debtor's proposed debtor-in-possession lenders, the parties required to receive notice pursuant to the Lease and the Debtor's twenty (20) largest unsecured creditors; that no further notice is necessary; that the relief sought in the Motion is in the best interests of the Debtor, its estate, and its creditors; and that good and sufficient cause exists for such relief.

Accordingly, it is hereby ORDERED as follows:

- 1. The Motion is GRANTED.
- 2. The Debtor is authorized to reject the Lease, and the Lease is hereby deemed rejected, effective as of the Petition Date.
- 3. The Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
- 4. Counsel for the Debtor is directed to serve a copy of this Order on all parties on the Master Service List and on the Lessor within three (3) days of the entry of this Order, and to file a certificate of service with the Clerk of the Court.
