**ORDER ON FINAL APPLICATION OF PACHULSKI STANG ZIEHL & JONES LLP  
FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT  
OF EXPENSES AS CO-COUNSEL TO THE OFFICIAL COMMITTEE OF  
UNSECURED CREDITORS FOR PIKE NURSERY HOLDING LLC**

IT APPEARING to the Court that Pachulski Stang Ziehl & Jones LLP, as co-counsel to the Official Committee of Unsecured Creditors for Pike Nursery Holding LLC, filed its Final Application for Allowance and Payment of Compensation and Reimbursement of Expenses on May 29, 2008 (Docket Entry No. 550) and filed its Amendment to Final Application Allowance and Payment of Compensation and Reimbursement of Expenses on June 16, 2008 (Docket Entry No. 576) (collectively, Docket Entry Nos. 550 and 576 shall be referred to as the "Application") requesting allowance of and final approval of fees in the amount of \$201,114.50 and expenses in

the amount of \$11,982.06 and that the United States Trustee requested that the Court defer ruling on the Application; and that after notice and a hearing, the Court finds that such compensation and reimbursement of expenses is fair and reasonable; it is hereby ORDERED AND ADJUDGED as follows:


1. The Application is approved, as set forth herein, subject to objection to this Order filed by the United States Trustee within thirty (30) days of its entry. If no objection is filed by the U.S. Trustee as set forth above, this Order shall constitute a final order granting the Application. If an objection is timely filed by the U.S. Trustee, a hearing will be scheduled upon further notice to consider such objection.

2. Subject to objection as set forth above, Pachulski Stang Ziehl & Jones LLP is hereby awarded and allowed final compensation in the amount of \$201,114.50 for fees and of \$11,982.06 for expenses in reimbursement for expenses incurred for the Debtor.

The Clerk of Court shall serve this Order on the parties identified in the attached Distribution List. No other or further notice is required.
