ORDER ON FINAL APPLICATION OF POWELL GOLDSTEIN LLP FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES AS CO-COUNSEL TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS FOR PIKE NURSERY HOLDING LLC

IT APPEARING to the Court that Powell Goldstein LLP, as co-counsel to the Official Committee of Unsecured Creditors for Pike Nursery Holding LLC, filed its Final Application for Allowance and Payment of Compensation and Reimbursement of Expenses on May 30, 2008 (Docket Entry No. 557) (as amended, the "Application"), requesting allowance of and final approval of fees of \$215,464.00 and expenses of \$7,340.00 and that the United States Trustee requested that the Court defer ruling on the Application; at the hearing, Powell Goldstein LLP orally amended the Application to seek additional compensation of \$1,820.00 for attorneys' fees

for filing its fee application, responding to the United States Trustee's objection, and appearing at the hearing; and that after notice and a hearing, the Court finds that such compensation and reimbursement of expenses is fair and reasonable; it is hereby ORDERED AND ADJUDGED as follows:

- 1. The Application is approved, as set forth herein, subject to objection to this Order filed by the United States Trustee within thirty (30) days of its entry. If no objection is filed by the United States Trustee as set forth above, this Order shall constitute a final order granting the Application. If an objection is timely filed by the United States Trustee, a hearing will be scheduled upon further notice to consider such objection.
- 2. Subject to objection as set forth above, Powell Goldstein LLP is hereby awarded and allowed final compensation in the amount of \$217,284.00 for fees and of \$7,340.40 for expenses in reimbursement for expenses incurred for the Debtor.

The Clerk of Court shall serve this Order on the parties identified in the attached Distribution List. No other or further notice is required.
