
**WRITTEN REQUEST OF WRH HOLDINGS, LLC D/B/A
CANTRELL FOR PAYMENT OF SECTION 503(b)(9) CLAIM
PURSUANT TO ORDER ENTERED ON DECEMBER 31, 2008**

PLEASE TAKE NOTICE that WRH Holdings, LLC, d/b/a Cantrell ("WRH Holdings, LLC"), by and through counsel, hereby files and provides this written request for payment of its claim pursuant to Section 503(b)(9) of the Bankruptcy Code and pursuant to the Order entered on December 31, 2008, relating to Goods delivered to and received by Debtor Pilgrim's Pride Corporation within twenty (20) days before the date of the commencement of

Debtors' bankruptcy cases. In support of this request, WRH Holdings, LLC attaches hereto and incorporates herein as Exhibit "A" a summary of invoices, invoices, picking tickets/shipping documents, tracking summaries, and purchasing orders ("Documents") for Goods delivered within twenty (20) days of Debtors' bankruptcy filings. WRH Holdings, LLC delivered machinery parts which are described in the attached Documents. The attached Documents provide information confirming shipping terms and the value of the Goods, the dates of delivery of the Goods to Debtors which dates were all within twenty (20) days of the bankruptcy filings, confirmation that the value of the Goods set forth in this request is for Goods only, identification of the Goods for which this section 503(b)(9) is being asserted, and identification to which Debtor the Goods were shipped. In addition, WRH Holdings, LLC shows that WRH Holdings, LLC sold and delivered the Goods at the request of Debtor Pilgrim's Pride Corporation to Debtors' various plants and locations within twenty (20) days prior to the bankruptcy filing date of December 1, 2008, that its claim is for the value of Goods only and not services, that WRH Holdings, LLC will not be receiving payment for the Goods from any other source, and that WRH Holdings, LLC has not filed duplicate or similar claims with Debtors regarding the Goods with the only exception being that WRH Holdings, LLC forwarded reclamation notices to Debtor Pilgrim's Pride Corporation on December 17, 2008, which notices covered goods delivered within forty-five (45) days of the bankruptcy filings and which notices included demands for protection of claims under 11 U.S.C. Section 503(b)(9). A copy of the reclamation notices without exhibits is attached hereto as Exhibit "B". WRH Holdings, LLC's Section 503(b)(9) demand and request for payment and an administrative claim for goods delivered within twenty (20) days before the bankruptcy filing date is in the amount of \$52,780.28.

WHEREFORE, WRH Holdings, LLC respectfully requests payment and recognition of its claim for \$52,780.28 as an administrative priority claim pursuant to Section 503(b)(9) of the Bankruptcy Code and for such other relief as the Court deems just and proper.


