Gateco Oil Company, Inc. (the "Seller"), hereby serves this demand for reclamation of goods pursuant to 11 U.S.C. § 546(c) upon Pilgrim's Pride Corporation (the "Debtor"), the debtor in this chapter 11 case, and its counsel.

1. The name and address of the Seller is as follows:

2. The Seller is the business of selling and distributing oil, diesel fuel and related products.

3. The Debtor filed a chapter 11 case in the United States Bankruptcy Court for the Northern District of Texas on December 1, 2008 (the "Petition Date").

4. The Seller shipped from Greensboro, North Carolina in the ordinary course of its business, and the Debtor received at the Debtor's facilities in Cumnock, North Carolina and Bonlee, North Carolina, diesel fuel (the "Goods") on the dates and in the amounts set forth below:

5. Copies of the invoices, delivery receipts and other pertinent information supporting each delivery and receipt of the Goods are attached as composite Exhibit A.

6. The terms of payment of each invoice were net 15 days.

7. No services are included in this reclamation demand.

8. As of the date of this reclamation demand, the Seller has not filed any other claim with the Debtor regarding the Goods.<sup>1</sup>

9. The Goods have a value of \$84,896.27.

<sup>1</sup> Once procedures are established by the Bankruptcy Court for the submission of administrative claims under Section 503(b)(9) of the Bankruptcy Code, the Seller anticipates submitting a claim under that statute since the Goods were received by the Debtor within twenty (20) days of the Petition Date. By filing this reclamation demand, the Seller specifically reserves all of its rights and remedies under applicable law, including its rights under Section 503(b)(9) of the Bankruptcy Code.


