**ORDER REGARDING DEBTORS' MOTION PURSUANT TO SECTIONS
105(a) AND 362 OF THE BANKRUPTCY CODE STAYING CERTAIN LITIGATION**
(Relates to Docket No. 515)

Upon the motion, dated January 12, 2009, and the notice of modifications with respect thereto, dated January 16, 2009 (collectively, the "Motion"), of Pilgrim's Pride Corporation ("PPC") and its affiliated debtors in the above-referenced chapter 11 cases, as

debtors and debtors in possession (collectively, the “Debtors”),¹ pursuant to sections 105(a) and 362(a) of the Bankruptcy Code² to extend the automatic stay with respect to the Third Party Defendants in the Actions listed on Exhibit A annexed hereto, all as more fully set forth in the Motion; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided to the Notice Parties, and it appearing that no other or further notice need be provided; and it appearing that certain objections (the “Objections”) to the Motion were filed; and a hearing having been held on February 10, 2009 to consider whether the relief requested in the Motion should have been brought through commencement of adversary proceedings (the “Hearing”); and the appearances of all interested parties having been noted in the record of the Hearing; and upon the record of the Hearing, and all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Motion is adjourned to March 10, 2009 at ^{10:30 a.m.}~~10 a.m.~~ (CT) to consider whether relief requested in the Motion should be granted with respect to Actions Nos. 1 through 63, 68 through 70, and 93 on the attached Exhibit A; and it is further

ORDERED that the Motion is denied with respect to all other Actions listed on Exhibit A (the “Other Actions”) without prejudice to the Debtors commencing adversary proceedings as to such Actions to seek the relief requested in the Motion; and it is further

ORDERED that the Debtors may commence adversary proceedings with respect to the Other Actions by category rather than by filing a separate adversary proceeding for each Other Action; and it is further

ORDERED that this Court hereby retains jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and/or enforcement of this Order.
