

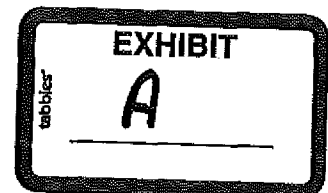

**CROWN EQUIPMENT CORPORATION'S REQUEST
FOR ALLOWANCE OF ADMINISTRATIVE EXPENSES
PURSUANT TO §503(b)(9)**

Comes now Crown Equipment Corporation ("Crown"), by and through counsel, and files this its *Request for Allowance of Administrative Expenses Pursuant to §503(b)(9)* for goods delivered to Debtor within twenty (20) days prior to the Chapter 11 Bankruptcy Petition and in support thereof :

1. Pilgrims Pride Corporation ("PPC") and its affiliated Debtors filed voluntary Chapter 11 Petitions on December 1, 2008.
2. Crown provided goods to Debtor in the ordinary course of business within 20 days before the filing of the Petition.
3. The value of the goods provided during the 20 days prior to the filing of the Petition was \$6,990.23.
4. Crown has not been paid for these goods.
5. Crown attaches hereto documentation of the goods delivered to PPC within the 20 days prior to the Petition.
6. Crown has complied with the terms of the Order entered December 31, 2008, pursuant to Section 503(b)(9) of the Bankruptcy Code.



7. Crown is entitled to an Administrative Claim under Section 503(b)(9) of the Bankruptcy Code for the value of the goods provided.

8. Crown does not intend and hereby does not waive any rights it may otherwise assert against Debtor with respect to goods nor with respect to any other rights and/or remedies it may have against Debtor.

WHEREFORE, Crown respectfully requests it be allowed an Administrative Claim in the amount of \$6,990.23 pursuant to Section 503(b)(9) of the Bankruptcy Code, and for such other and further relief as it may be entitled.
