

**ORDER GRANTING DEBTORS' TWENTY-FIFTH OMNIBUS
OBJECTION TO CLAIMS (CLAIMS FILED IN THE WRONG CASE)**

(Relates to Docket No. 3441)

Pursuant to the Order Approving Procedures for Objecting to Proofs of Claim and for Notifying Claimants of Such Objections [Docket No. 2723] (the "Claims Objections Procedures Order"), and upon the Twenty-fifth Omnibus Objection to Claims (Claims Filed in the Wrong Case) [Docket No. 3441] (the "Twenty-fifth Omnibus Objection") of Pilgrim's Pride

Corporation and its affiliated debtors in the above-referenced chapter 11 cases, as debtors and debtors in possession (collectively, the “Debtors”),¹ objecting to the Wrongly-Filed Claims² as having been filed in the wrong chapter 11 case and seeking to amend such claims, as more fully set forth in the Twenty-fifth Omnibus Objection; and the Court having jurisdiction to consider the Wrongly-Filed Claims and grant the requested relief in accordance with 28 U.S.C. §§ 157 and 1334; and consideration of the Wrongly-Filed Claims being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Debtors having provided notice of the Twenty-fifth Omnibus Objection to the Notice Parties; and the Court having held a hearing to consider the requested relief (the “Hearing”) with the appearances of all interested parties noted in the record of the Hearing; and the Court having found sufficient legal and factual grounds for amending the Wrongly-Filed Claims listed on Exhibit A; and the Court having determined that the legal and factual bases set forth in the Twenty-fifth Omnibus Objection establish just and sufficient cause to grant the requested relief herein; and therefore, it is:

ORDERED that pursuant to section 502(b) of the Bankruptcy Code, each Wrongly-Filed Claim listed on Exhibit A hereto is hereby deemed amended so that each such claim is (i) deemed to have been filed in the chapter 11 case of the Correct Debtor, and (ii) deemed expunged from the chapter 11 case of the Named Debtor; and it is further

ORDERED that, notwithstanding the foregoing, the purpose of this Order is to clarify the correct case in which each Wrongly-Filed Claim should have been filed, and nothing herein shall be deemed an Order expunging or disallowing any Wrongly-Filed Claim from these chapter 11 cases altogether; and it is further

ORDERED that the Debtors shall retain the right to object to any Wrongly-Filed Claim on any other ground; and it is further

ORDERED that the Debtors shall serve a copy of this Order on each Notice Party; and it is further

ORDERED that this Court hereby retains jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and/or enforcement of this Order.
