DECLARATION OF CHRISTOPHER L. REXROAT IN SUPPORT OF DEBTORS'
APPLICATION PURSUANT TO SECTIONS 327(a) AND 328(a) OF THE
BANKRUPTCY CODE FOR AUTHORIZATION TO EMPLOY AND RETAIN
AMERICAN APPRAISAL ASSOCIATES, INC. AS VALUATION CONSULTANTS TO
THE DEBTORS NUNC PRO TUNC TO SEPTEMBER 16, 2009

1. I am the Associate General Counsel of American Appraisal Associates, Inc. ("American Appraisal"), which maintains offices at, among other places, 411 E. Wisconsin Avenue, Milwaukee, Wisconsin and 12750 Merit Drive, Dallas, TX 75251, and am duly authorized to make this Declaration on behalf of American Appraisal. I submit this Declaration in support of the application (the "Application") of the above-captioned debtors and debtors in possession (collectively, the "Debtors"), pursuant to sections 327(a) and 328(a) of title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (the "Bankruptcy Code"), and Rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), for an order authorizing the employment and retention of American Appraisal as valuation consultants to the Debtors *nunc pro tunc* to September 16, 2009, for the purpose of providing valuation consulting services to the Debtors during these chapter 11 cases. Except as otherwise indicated, I have personal

knowledge of the matters set forth herein and, if called as a witness, would testify competently thereto.<sup>2</sup>

#### **Qualifications of American Appraisal**

- 2. American Appraisal is a leading, global, independent professional valuation firm. American Appraisal and its subsidiaries provide a wide range of professional valuation, appraisal and consulting services to corporate, governmental and institutional clients on a worldwide basis. American Appraisal currently has approximately 850 employees worldwide and offices in 28 countries. American Appraisal is a wholly owned subsidiary of AAManagement Group, Inc., which in turn is owned by shareholders worldwide who are managers and employees of American Appraisal.
- 3. American Appraisal's professionals have served as valuation experts in numerous chapter 11 cases, including Vertis Holdings, Inc. (Delaware); Armstrong World Industries, Inc. (Delaware); US Airways Group, Inc. (E.D. Virginia); Interstate Bakeries Corporation (W.D. Missouri); Delta Airlines, Inc. (S.D.N.Y.); Solutia, Inc. (S.D.N.Y.); WorldCom, Inc. (S.D.N.Y.); Lyondell Chemical Company (S.D.N.Y.); Aventine Renewable Energy Holdings, Inc. (Delaware); Philadelphia Newspapers, LLC (E.D. Pennsylvania) and others.

#### Services To Be Rendered

4. The nature and extent of the services for which the Debtors propose to have American Appraisal retained are more fully set forth in the Engagement Letter and include, but are not limited to, the following, as requested by the Debtors and agreed to by American Appraisal:

- (i) performing calculation of the business enterprise value and undiscounted cash flows expected to result from the use and eventual disposition of PPC's operating assets;
- (ii) identifying and valuing intangible assets and estimating the remaining life of each intangible assets;
- (iii) valuing the personal property and real estate related to the idled facilities listed in Exhibit C to the Engagement Letter;
- (iv) valuing the personal property and real estate related to the operating facilities listed in Exhibit B to the Engagement Letter;
- (v) reviewing lease data for leased real property to assess the potential significance of any leasehold interests;
- (vi) reviewing and analyzing market data regarding assets and liabilities comparable to that of the Debtors'; and
- (vii) providing such other valuation services for the Debtors as may be necessary or desirable, to the extent permitted under professional standards and as agreed to between the Debtors and American Appraisal.

#### **Disinterestedness of Professionals**

- 5. None of the employees of American Appraisal who will work on this engagement are related or connected to the presiding judge of the United States Bankruptcy Court for the Northern District of Texas for this case or the United States Trustee for the Northern District of Texas or to any employee in the office thereof.
- 6. American Appraisal may in the past have been retained by, may presently be retained by, and may in the future perform services for, entities that are determined to be

creditors, lenders, shareholders, insurers, customers, competitors, vendors, contract counterparties, or otherwise parties-in-interest with respect to the Debtors' chapter 11 estates. To the best of American Appraisal's current knowledge, subject to the caveats in this paragraph and in the following paragraphs, all such services are or will be focused on matters other than existing commercial relationships or transactions between such companies and the Debtors.

- 7. American Appraisal is an independent service provider and, as such, provides valuation services to competing companies and does so in a manner that protects the confidentiality of each client's information. American Appraisal's expertise which the Debtors desire to utilize for the purposes described herein derives in part from its service to many different clients in the industries and business sectors in which the Debtors operate. American Appraisal maintains a central database of clients and engagements performed for its clients, which is kept principally for record keeping purposes.
- 8. In order to make the representations set forth herein, I worked with American Appraisal personnel who are responsible for maintaining American Appraisal's Global Client Information database (the "GCI") to conduct a review of our current and former client engagements for purposes of determining American Appraisal's status as a disinterested party in this case. The GCI is a database of engagements, organized by client name, which includes all client engagements from our US-based operations since 1996 and is designed to include all foreign subsidiary client engagements since 1993.
- 9. A summary of the results of this search are attached hereto as Schedule 1. This summary indicates ("Yes" or "No") all American Appraisal client engagements (including individual contacts) going back approximately 13 years for our US-based operations and 16

years for non-US affiliates, using the list of Interested Parties provided to American Appraisal by the Debtors or their professionals.

- 10. To the best of my knowledge and information, after reasonable inquiry, except as set forth herein, the employees of American Appraisal who will work on this engagement: (i) do not have any connection with the Debtors or their affiliates, their creditors, or any other party-in-interest, or their respective attorneys and accountants except as described herein or in connection with consulting services provided to any such party on matters unrelated to these proceedings; (ii) are "disinterested persons," as that term is defined in section 101(14) of the Bankruptcy Code; and (iii) do not hold or represent any interest adverse to the Debtors' estates.
- 11. To the best of my knowledge and information, after reasonable inquiry, except as set forth herein, American Appraisal: (i) does not hold or represent an interest adverse to the Debtors' estates; (ii) is not a creditor, an equity security holder or an insider of the Debtors;<sup>3</sup> (iii) is not and has not been, within two years before the Commencement Date, a director, officer or employee of the Debtors; and (iv) does not have an interest materially adverse to the interests of the Debtors' estates or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with, or interest in the Debtors, or for any other reason.
- 12. Accordingly, I believe American Appraisal is a "disinterested person" as that term is defined in Section 101(14), as modified by Section 1107(b) of the Bankruptcy Code.

13. American Appraisal will, if it believes it appropriate, file supplemental disclosures should additional information come to its attention concerning disclosable matters.

#### **Confidentiality**

14. American Appraisal has agreed to maintain the confidentiality of the Debtors' information and will not disclose it or use it for any purpose other than the Debtors' engagement. All files, documents and work papers developed during the engagement will be retained by American Appraisal for five years. During this retention period, the Debtors' shall have full access to those documents, subject only to reasonable notification. If lawfully compelled to disclose any such documents, American Appraisal will promptly provide the Debtors with written notice so that they may seek a protective remedy, if available.

#### **Professional Compensation**

- 15. Pursuant to the terms and conditions of the Engagement Letter, and subject to the Court's approval, American Appraisal estimates that it will charge a total of \$493,000 for the engagement. In the event there is an increase in the scope of activities or if extraordinary consultation is requested, American Appraisal may require a supplemental fee in accordance with the fee structure set forth in the Application.
- 16. American Appraisal shall invoice the Debtors for expenses at actual cost without markup. These expenses include those costs for such items as office and report processing, travel, living, computer charges, postage and copying, which are directly incurred by its staff while executing the work. American Appraisal also invoices a flat expense fee of \$50 per billable day ("Online Information Service" fee) for access to various online databases and other similar charges incurred in the ordinary course of its valuation engagements.
