ORDER GRANTING DEBTORS' THIRTY-FOURTH OMNIBUS OBJECTION TO CLAIMS (SATISFIED CLAIMS) AND MOTION REQUESTING DETERMINATION OF TAX LIABILITY PURSUANT TO SECTIONS 105 AND 505 OF THE BANKRUPTCY CODE

Pursuant to the Order Approving Procedures for Objecting to Proofs of Claim and for Notifying Claimants of Such Objections [Docket No. 2723] (the "Claims Objections Procedures Order"), and upon the Thirty-Fourth Omnibus Objection to Claims (Satisfied Claims) and Motion Requesting Determination of Tax Liability Pursuant to Sections 105 and 505 of the Bankruptcy Code (the "Thirty-Fourth Omnibus Objection") of Pilgrim's Pride Corporation and

its affiliated debtors in the above-referenced chapter 11 cases, as debtors and debtors in possession (collectively, the "Debtors"), objecting to the Satisfied Claims as more fully set forth in the Thirty-Fourth Omnibus Objection; and the Court having jurisdiction to consider the Satisfied Claims and grant the requested relief in accordance with 28 U.S.C. §§ 157 and 1334; and consideration of the Satisfied Claims being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Debtors having provided notice of the Thirty-Fourth Omnibus Objection to the Notice Parties; and the Court having held a hearing to consider the requested relief (the "Hearing") with the appearances of all interested parties noted in the record of the Hearing; and the Court having found sufficient legal and factual grounds for disallowing the Satisfied Claims listed on Exhibit A; and the Court having determined that the legal and factual bases set forth in the Thirty-Fourth Omnibus Objection establish just and sufficient cause to grant the requested relief herein; and therefore, it is:

ORDERED that the Thirty-Fourth Omnibus Objections is granted; and it is further ORDERED, pursuant to section 502(b) of the Bankruptcy Code, each Satisfied Claim listed on **Exhibit A** hereto is hereby disallowed and expunged in its entirety; and it is further ORDERED that, notwithstanding the foregoing, nothing herein shall be deemed an Order invalidating any payment made pursuant to the Taxing Authorities Orders; and it is further

ORDERED that the Debtors shall serve a copy of this Order on each Notice Party; and it is further
