## **ATTACHMENT TO PROOF OF CLAIM OF CASE FARMS, LLC**

Case Farms, LLC (“**Case Farms**”) hereby supplements (this “**Attachment**”) the attached proof of claim (the “**Claim**”) as set forth below. The Attachment is incorporated as an integral component of the Claim.

### **BACKGROUND**

On February 18, 2014 (the “**Petition Date**”), Quantum Foods, LLC and its affiliated debtors<sup>1</sup> filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (11 U.S.C. §§ 101 *et. seq.*, the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”), jointly administered at Case No. 14-10318-KJC.

Case Farms is a poultry farming and processing entity and the Debtors purchased product from Case Farms to enable the Debtors to run their meat processing and distribution business. Between the Petition Date and September 30, 2014, Case Farms provided the Debtors with certain product which remains unpaid. A chart summarizing the invoices for such unpaid goods (the “**Invoices**”) is attached hereto as **Exhibit A**. True and correct copies of the Invoices and proofs of delivery are attached hereto as **Exhibit B**.

### **STATEMENT OF CLAIM**

Case Farms hereby asserts a priority administrative expense claim against the Debtors pursuant to sections 503(b)(1) and 507(a)(2) of the Bankruptcy Code for the unpaid goods as detailed in the attached Invoices and proofs of delivery, totaling not less than **\$387,709.44**.

### **RESERVATION OF RIGHTS**

1. The filing of this Claim is not intended to be, and should not be construed as, an election of remedies or a waiver or limitation of any rights, remedies, claims, or interests of Case Farms.

2. Case Farms reserves all rights to (i) amend, update, or supplement this Claim at any time and in any respect, and (ii) file additional proofs of claim.

3. Case Farms does not waive, and fully reserves, any and all claims against the Debtors that may arise post-petition, post-confirmation, or after the conversion of this case to a case under any other chapter of the Bankruptcy Code.

4. Claimant reserves the right to claim post-petition interest, costs and attorneys' fees with respect to the Claim to the maximum extent permitted by law.

5. Case Farms reserves all rights of setoff and recoupment to which it may be entitled under applicable law.

6. By filing this Claim, Case Farms does not submit to the jurisdiction of the Bankruptcy Court for any purpose, other than with respect to the claim asserted in this Claim, and Case Farms does not waive, and specifically preserves, all of its procedural and substantive defenses to any claim that may be asserted against Case Farms by the Debtors, its affiliates, any trustee of the Debtors' estates, the official committee of unsecured creditors of the Debtors, or any other person or entity. Neither this Claim nor any prior or later appearance, pleading, claim, or suit shall waive any right of Case Farms to trial by jury in any proceeding so triable in these cases or any case, controversy, or proceeding related to this case.

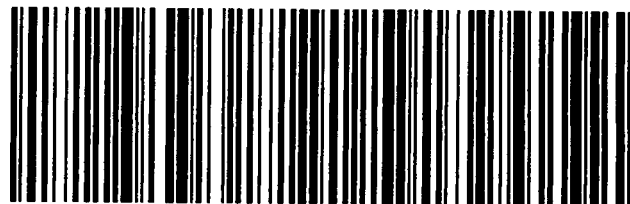
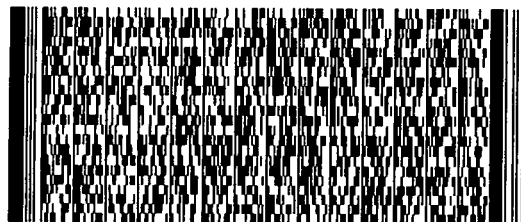

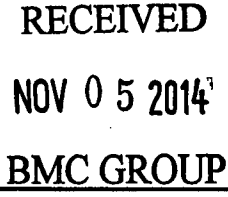

Case Farms, LLC (“**Case Farms**”) hereby supplements (this “**Attachment**”) the attached proof of claim (the “**Claim**”) as set forth below. The Attachment is incorporated as an integral component of the Claim.

### **BACKGROUND**

On February 18, 2014 (the “**Petition Date**”), Quantum Foods, LLC and its affiliated debtors<sup>1</sup> filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (11 U.S.C. §§ 101 *et. seq.*, the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”), jointly administered at Case No. 14-10318-KJC.

Case Farms is a poultry farming and processing entity and the Debtors purchased product from Case Farms to enable the Debtors to run their meat processing and distribution business. Between the Petition Date and September 30, 2014, Case Farms provided the Debtors with certain product which remains unpaid. A chart summarizing the invoices for such unpaid goods (the “**Invoices**”) is attached hereto as **Exhibit A**. True and correct copies of the Invoices and proofs of delivery are attached hereto as **Exhibit B**.

Case Farms hereby asserts a priority administrative expense claim against the Debtors pursuant to sections 503(b)(1) and 507(a)(2) of the Bankruptcy Code for the unpaid goods as detailed in the attached Invoices and proofs of delivery, totaling not less than **\$387,709.44**.

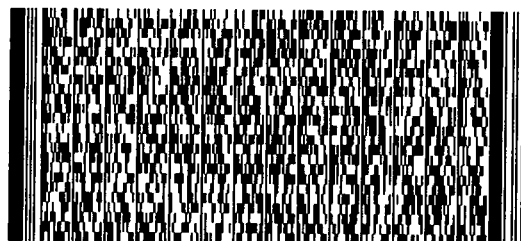
