**MOTION OF CREEKSTONE FOR ALLOWANCE AND TO COMPEL PAYMENT OF
ITS ADMINISTRATIVE EXPENSE CLAIM PURSUANT TO 11 U.S.C. § 503(b)(9)**

Creekstone Farms Premium Beef, LLC, ("Creekstone") by and through its undersigned attorneys, hereby moves for an order allowing its administrative expense claim pursuant to 11 U.S.C., §§503(a) and 503(b)(9) and directing the above captioned debtors (the "Debtors") to pay Creekstone its administrative expense claim pursuant to 11 U.S.C., §§503(a), 503(b)(9) and 507(a)(2) (this "Motion"), and respectfully states as follows:

JURISDICTION

1. This Court has jurisdiction to consider this motion pursuant to 28 U.S.C., §157 and 1334. Consideration of this Application is a core proceeding under 28 U.S.C. §157(b). Venue is proper in this District pursuant to 28 U.S.C. §1408 and 1409. The statutory predicate for the relief requested herein is 11 U.S.C. §§ 503(a), 503(b)(9) and 507(a)(2).

BACKGROUND

2. On February 18, 2014 (the "Petition Date"), each of the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware.

3. On May 22, 2014, the Court entered the *First Amended Order Amending Final Order (I) Authorizing Post-Petition Financing, (2) Granting Liens and Providing Super Priority*

Administrative Expense Priority, (3) Authorizing Use of Cash Collateral and Providing for Adequate Protection, and (4) Modifying the Automatic Stay, Pursuant to Sections 105, 361, 362, 363 and 364 of the Bankruptcy Code and Bankruptcy Rules 2002, 4001 and 9014 [Docket No. 353], whereby payment of claims are authorized pursuant to section 503(b)(9) of the Bankruptcy Code from funds allocated to the estate for payment of administrative expense claims in accordance with the or any other source of funds that may become available to satisfy administrative expense claims in these cases.

4. Prior to the Petition Date, Creekstone sold goods to the Debtors in the ordinary course of the business of the Debtors.

5. Creekstone made two deliveries of meat products on February 7, 2014 (Invoice 1032618) and February 10, 2014 (Invoice 1032826), i.e., during the twenty day period immediately preceding the Petition Date. Each sale of goods, the delivery date, and value of each shipment is detailed on the annexed Exhibit "A."

6. Each sales of goods was delivered by carrier, Rains & Sons, directly to the Debtor. Copies of the respective Invoices and Bills of Lading are annexed hereto as Exhibit "A."

7. Creekstone is therefore owed \$111,263.89 as an administrative expense pursuant to 11 U.S.C. §503(b)(9).

8. On October 30, 2014, Creekstone filed a claim in this bankruptcy case (Claim No. 193), prior to the claims bar date of November 7, 2014.

9. To date, the Debtors have failed to pay Creekstone for the value of the goods. Upon information and belief, the Debtors have used all the goods which were sold to the Debtors in its ordinary course of business.

ARGUMENT

10. Section § 503(b)(9) of the Bankruptcy Code provides that "[a]fter notice and a hearing, there shall be allowed, administrative expenses, other than claims allowed under 502(f) of this title, including . . . the value of any goods received by the debtor within 20 days before the date of commencement of a case under this title in which the goods have been sold to the debtor in the ordinary course of such debtor's business." 11 U.S.C. § 503(b)(9).

11. The goods were sold by Creekstone and received by the Debtors within 20 days of the Petition Date.

12. The goods have been sold to the Debtors in the ordinary course of the Debtors' business.

13. The goods were necessary for the Debtors to operate their business, and in fact, the goods have been completely consumed in the operation of the Debtors' business, therefore, Creekstone has provided a benefit to the estate for which it has not been compensated.

14. Pursuant to 11 U.S.C. §§503(a), 503(b)(9) and 507(a)(2), Creekstone is entitled to an allowed administrative expense claim in the amount of \$111,263.89. Creekstone is also seeking payment of the administrative expense claim within five (5) business days of entry of an order approving this Motion.

NOTICE OF MOTION

15. Notice of this Motion has been given to: (i) the Debtors, (ii) counsel to the Debtors, (iii) the Office of the United States Trustee for the District of Delaware, (iv) counsel to the Official Committee of Unsecured Creditors, and (v) any party requesting notice pursuant to Bankruptcy Rule

2002. In light of the nature of the relief requested herein, Central Beef submits that no other or further notice is necessary.

WHEREFORE, Creekstone respectfully requests that the Court enter an order allowing its administrative expense claim pursuant to 11 U.S.C. §§503(b)(9) and 507(a)(2) and directing the Debtors to pay Creekstone its administrative expense claim within five (5) business days of the date of such Order, and grant Creekstone such other and further relief as this Court deems just and proper.
