26 reference number for the document demonstrated it was in fact recorded.


27 2. Exhibit "B" is a true and correct copy of Debtor's schedules, document no 15
28 on the court's docket, at pages 16 and 78. The schedules are subject to judicial notice under

1 *State of Fla. Bd. of Trustees of Internal Imp. Trust Fund v. Charley Toppino & Sons, Inc.*, 514
2 F.2d 700, 704 (5th Cir. 1975)” “It is not error, ... for a court to take judicial notice of related
3 proceedings and records in cases before that court.” *Id.*

4 3. Exhibit “C” is a true and correct copy of a printout from the website for
5 California Division of Oil, Gas & Geothermal Resources (“DOGGR”). The printout is subject
6 to judicial notice under *In re Wellbutrin SR/Zyban Antitrust Litig.*, 281 F. Supp. 2d 751, 755
