
DECLARATION OF REBECCA WILLIAMS

“My name is Rebecca Williams. I am over 21 years of age, of sound mind, and I am otherwise competent to make this Declaration. The facts in this Declaration are within my personal knowledge and are true and correct. My statements in this Declaration are based on my personal observation and recollections as well as review of business records of Offshore Rental, Ltd. d/b/a Tiger Offshore Rentals.

1. “I am a customer service representative with Offshore Rental, Ltd. d/b/a Tiger Offshore Rentals (“Tiger”). By virtue of my possession, I have personal knowledge of the business transactions between Tiger and its customers, including Century Exploration New Orleans, LLC (“CENO”).
2. I am also a custodian of Tiger’s accounts receivable records. Attached hereto as Exhibit A-1 are true and correct copies of Tiger’s invoices and delivery tickets to CENO reflecting equipment rented to CENO from October 26, 2015 through December 31, 2015 and the unpaid charges for those rentals. These said records are kept by me for Tiger in the regular course of business. All of the documents reflect information gathered in the regular course of Tiger’s business. It was the regular course of business for an employee or representative of Tiger, with knowledge of the act, event, condition or opinion recorded, to make the record or to transmit information thereof to be included in the record, and such information was recorded at, near or reasonably soon after the time of the act, event, condition, or opinion occurred. The documents are exact duplicates of the original records.
3. As illustrated in Exhibit A-1, which is incorporated in this Declaration by reference for all purposes, CENO rented numerous pieces of equipment from Tiger in the ordinary course of its business, including marine portable tanks and IM 101 transport tanks for storage and transportation of drilling, production and completion fluids or other liquids; drum racks used for transporting and storing drums filled with materials, product or byproducts; cuttings boxes used to store rock and other material removed from the borehole by the drilling operations; dry goods boxes used to store food and other supplies for carrying on the operations; open top baskets and cargo containers used to transport equipment and other supplies; and slings and accessories necessary for hoisting such equipment. CENO incurred \$9,616.92 for these rentals after filing of its bankruptcy case and through December 31, 2015. The details of such charges are accurately reflected in
