ORDER APPOINTING SUCCESSOR LIQUIDATING TRUSTEE OF THE RAAM GLOBAL ENERGY COMPANY ET AL. LIQUIDATING TRUST [This instrument relates to Docket No. 487]

This matter comes before the Court on the Expedited Motion to Approve Appointment of Successor Liquidating Trustee of the RAAM Global Energy Company et al Liquidating Trust (the "Liquidating Trust," and the "Motion") filed by Douglas J. Brickley, as Trustee for the Liquidating Trust. The Court, having considered the Motion, any responses thereto, and the evidence and arguments presented, finds that the Motion is meritorious and should be granted on the terms set forth herein.

ACCORDINGLY, IT IS HEREBY ORDERED THAT:

- 1. The Motion is **GRANTED** as set forth herein.
- 2. The appointment of Robert E. Ogle as Successor Liquidating Trustee of the Liquidating Trust ("Ogle") is hereby approved and shall be effective immediately upon the event of the following conditions: (i) entry of this Order; and (ii) the filing by Ogle of an instrument accepting such appointment and agreeing to be bound by the terms of the Trust Agreement governing the Liquidating Trust. Upon such appointment, Ogle shall be and is vested with all the rights, powers, trusts and duties of the Liquidating Trustee under the Trust Agreement governing the Liquidating Trust. Ogle shall provide written notice of his appointment to the Liquidating Trust Beneficiaries as soon thereafter as is practicable.

2. The resignation of Douglas J. Brickley as Liquidating Trustee of the Liquidating Trust is hereby approved and shall be effective immediately upon the event of the following conditions: (i) the entry of this Order; and (ii) the filing by Ogle of an instrument accepting appointment as the Successor Liquidating Trustee of the Liquidating Trust and agreeing to be bound by the terms of the Trust Agreement governing the Liquidating Trust. Mr. Brickley shall take any and all acts necessary under section 6.5 of the Trust Agreement, and shall otherwise assist and cooperate in effecting the assumption of his obligations and functions by Ogle.
