**APPELLEES' DESIGNATION OF ADDITIONAL ISSUES AND
ITEMS TO BE INCLUDED IN THE RECORD ON APPEAL**

Appellees' RCN Corporation ("RCN") and certain of its direct and indirect subsidiaries, debtors and debtors-in-possession in the above-captioned cases (collectively, the "Debtors"), pursuant to Rule 8006 of the Federal Rules of Bankruptcy Procedure, hereby present their designation of additional issues and items to be included in the record on the appeal filed by Deborah K. Craig from Order Denying Motion to File a Late Proof of Claim (filed in Case No. 04-13638, Docket No. 352).

Counterdesignation of Issues on Appeal:

1. Whether the Bankruptcy Court abused its discretion in determining that Ms. Craig failed to sustain her burden of establishing excusable neglect justifying the late filing of her claim.

2. Whether the Bankruptcy Court abused its discretion in refusing to permit the filing of a late proof of claim when the claim was purported to be a class action claim.

3. Whether the Bankruptcy Court abused its discretion in determining that the Department of Labor's right to file a claim as a governmental agency does not absolve Ms. Craig of her failure to file a claim on a timely basis.
