**STATEMENT PERTAINING TO SCHEDULES OF ASSETS AND LIABILITIES
AND STATEMENTS OF FINANCIAL AFFAIRS OF DEBTORS**

On April 7, 2010, each of the above-captioned debtors and debtors in possession (collectively, the “Debtors” or the “Company”) filed their Schedules of Assets and Liabilities and Statements of Financial Affairs (collectively, the “Schedules and Statements”) in accordance with Federal Rule of Bankruptcy Procedure 1007(b). This statement is incorporated by reference in, and comprises an integral part of, the Schedules and Statements, and should be referred to and reviewed in connection with any review of the Schedules and Statements.

Background

1. The Debtors own, operate and maintain a portfolio of 820 multi-family residential units divided among eight (8) separate apartment complexes (collectively, the “Apartments”) for lease in Tulsa, Oklahoma. RC Sooner Holdings, LLC (“RC Sooner”) is the

direct parent of eight (8) Oklahoma limited liability companies (collectively, the "RC LLCs"²), and together with RC Sooner, the "Purchasers") that were formed in October 2009 for the purpose of acquiring 100% of the membership interests of eight (8) existing Oklahoma limited liability companies that own the Apartments (collectively, the "Apartment LLCs"³). The purchase price of the acquisition included the assumption of approximately \$27 million in outstanding loans and mortgages (the "Loans and Mortgages") currently held by the Federal National Mortgage Association ("Fannie Mae").

2. Prior to October 29, 2009, the Apartment LLCs were owned by one or more related individuals and trust entities including Tim L. Remy, Tim J. Remy, Sherry E. Remy, L. Leon Remy, Robin E. Remy, Mona Remy Berke, the Sherry E. Remy Revocable Trust DTD July 14, 1997 and the L. Leon Remy Revocable Trust DTD July 14, 1997 (collectively, the "Remys") who held the Apartment LLCs through one or more holding companies (each, a "Remy Holding Company").

3. In or around early October 2009, Daniel Gordon ("Mr. Gordon"), who would be appointed Sole Manager of RC Sooner upon its formation later that month, commenced negotiations with the Remys through their general agent and real estate broker, William T. Strange ("Strange") and his firm Sperry Van Ness/William T. Strange Associates, Inc. ("SVN",

and together with Strange, the Remys and the Remy Holding Companies, the “Sellers”) for the purpose of evaluating a possible acquisition of the Apartments. As a result of these negotiations, RC Sooner was formed in furtherance of the exploration of the potential acquisition.

4. On or about October 29, 2009 (the “Closing Date”), each of the RC LLCs closed their purchases of 100% of the membership units of the Apartment LLCs from the Sellers by execution of several limited liability purchase agreements (collectively, the “Sale Agreements”) executed between each RC LLC and the respective Remy Holding Company holding each of the Apartment LLCs. The total consideration paid for the purchase of the Apartment LLCs under the Sale Agreements was \$29,772,661, which amount included the RC LLCs’ assumption of approximately \$26,958,973.00⁴ in Loans and Mortgages on the Apartments and an aggregate cash payment to the Sellers of approximately \$1,196,000.00.

5. During a transition period that lasted from the Closing Date to on or about December 31, 2009 (the “Transition Period”), one or more of the Sellers remained in possession of, and continued to operate, the Apartment LLCs on behalf of the Company for the purpose of facilitating the transition of the properties to the Purchasers.

6. Unbeknownst to the Purchasers, however, the Sellers had engaged in a pattern of intentional misconduct and fraudulent misrepresentation from the very outset of negotiations for the sale of the Apartments and the Apartment LLCs, which misrepresentations included the failure to inform the Purchasers that the Loans and Mortgages had been in default since approximately September 2, 2009, and remained in default as of the Closing Date.

7. Moreover, on information and belief, the information, books, and records received at the close of the sale of the Apartment LLCs may not have been complete or wholly accurate.

Schedules and Statements

8. The Debtors' property management company has made commercially reasonable efforts to ensure that the Schedules and Statements are accurate and complete based on information that was available at the time of preparation. However, as a result of the events precipitating the Debtors' bankruptcy filings, including, but not limited to, the discovery of significant fraudulent and otherwise improper conduct engaged in by the Sellers in connection with the sale and operation of the properties, many of the Debtors' historical financial and accounting records are unavailable or inaccurate. The Schedules and Statements will therefore likely require substantial amendment or revision to the extent additional information is uncovered in the course of the Debtors' ongoing investigation of the Sellers' prepetition conduct and activities. In addition, the Schedules and Statements may contain inadvertent errors or omissions.

9. Based on the foregoing, the Debtors must necessarily hereby qualify in their entirety the accuracy and completeness of their Schedules and Statements, and furthermore reserve their right to amend their Schedules and Statements as may be necessary or appropriate.

Summary of Reporting Policies for Schedules and Statements

10. The Schedules and Statements have been verified by Mr. Gordon to the best of his ability with significant reservations as to the accuracy and completeness of available

information as discussed herein. The Debtors' current management has operated the business for less than six months and has reason to believe that much of the information concerning the operations and financial condition of the business conveyed to the current owners in connection with the sale was inaccurate and that substantial business and financial records and other information relating to the operation of the business both before and after the sale remain in the hands of the Sellers or third parties connected with the sellers.

11. 2004 Motion Pending. To this end, the Debtors have filed a motion for an Order Authorizing Production of Documents and Examination of a Representative Pursuant to Bankruptcy Rule 2004 (Docket No. 44) (the "2004 Motion") seeking reasonable discovery from certain of the Sellers to uncover complete and accurate information critical to the administration of the Debtors' estates and the reorganization of their business. By the 2004 Motion, the Debtors seek to obtain additional information critical to their ability to amend their Schedules and Statements in order to provide complete and accurate information concerning their business.

12. Causes of Action. The Debtors have not set forth in detail as assets in their Schedules and Statements all potential causes of action that they may be entitled to assert against any third parties. The Debtors hereby reserve all of their rights with respect to any causes of action they may have against such third party defendants, and nothing contained in the Schedules and Statements shall be deemed a waiver of any such causes of action.

13. Claims. The Debtors reserve their right to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D. In addition, Schedules D, E, and F permit the Debtor to designate a claim as disputed, contingent and/or unliquidated. Any failure to designate a particular claim on any of these Schedules as disputed, contingent and/or

unliquidated does not constitute an admission that such claim is not subject to objection. The Debtors reserve their right to dispute, or assert offsets or defenses to any claim reflected on these Schedules as to nature, amount, liability or status, or to otherwise subsequently designate any claim as disputed, contingent, or unliquidated.

14. Tenant Security Deposits. While reasonable best efforts have been made to ensure the accuracy of the tenant security deposits listed on Schedule E, inadvertent errors or omissions may have occurred, for the reasons set forth in paragraph 10. To the extent that the Debtors learn that a listed security deposit was not made or was returned previously to the tenant, the Debtors reserve all rights to amend or supplement Schedule E as necessary.

15. Schedule G. Likewise, while reasonable best efforts have been made to ensure the accuracy of Schedule G, inadvertent errors or omissions may have occurred. The Debtors hereby reserve all rights to dispute the validity, status or enforceability of any contracts, agreements or leases set forth in Schedule G and to amend or supplement such Schedule as necessary. In addition, listing a contract or lease in this Schedule shall not be deemed an admission that such contract is an executory contract or unexpired lease, or that it is necessarily a binding, valid, and enforceable contract.


