NOTICE OF DEBTORS' DELINQUENCY PURSUANT TO STIPULATION

Oklahoma Energy Source, LLC (“OKES”), pursuant to that certain Stipulation Between The Debtors and Oklahoma Energy Source Resolving Oklahoma Energy Source, LLC’s Informal Objections to the Utility Motion entered by the Court on March 22, 2010 (the “Stipulation”) [D.I. No. 81], files its notification that the Debtors have failed to timely pay for post-petition goods. OKES has billed the Debtors on a bi-monthly basis for the utility services provided by OKES to the Debtors’ various apartment complexes (the "Apartment LLCs") and is owed the following post-petition amounts:

The Debtors have not paid OKES as set forth in the Stipulation and are delinquent in the total amount of \$26,603.18. Accordingly, OKES is entitled to be paid the sum of \$26,603.18 from the Utility Deposit Account as set forth in the Stipulation in order to cure said deficiency. Additionally, if, as requested by the Apartment LLCs in their Motion for Voluntary Dismissal of Certain Chapter 11 Cases [D.I. No. 155, Exhibit 1] their Chapter 11 cases are dismissed, such dismissal should not affect the Utility Deposit Account or the right of OKES to obtain the sum of \$26,603.18 from said Utility Deposit Account.
