REQUEST FOR ISSUANCE OF ORDER

Comes now Fannie Mae and hereby requests that the Court issue an Order regarding Fannie Mae's Motion To Compel Debtors' Compliance With the Stipulation And Consent Order Granting Motion Of Fannie Mae For Relief From The Automatic Stay Pursuant to 11 U.S.C. § 362(d) and Rule 4001 Of The Federal Rules Bankruptcy Procedure filed July 19, 2010 (Doc. No. 24) ("Motion to Compel"). As grounds therefore Fannie Mae would show the Court as follows:

1. A hearing on the Motion to Compel was held on August 19, 2010. Pursuant to stipulations of counsel at the hearing wherein Debtors' counsel agreed to use best efforts to procure the requested production within ten (10) days thereof, the Court entered a Minute Order specifying that Fannie Mae shall file a report regarding Debtors' production on or before August 30, 2010, advising the Court of the status of the production and further specifying that if Fannie

Mae is not satisfied with the progress of the production, it may request that the Court issue an Order on the Motion, at which time the matter will be taken under advisement (Doc. No. 102).

2. On August 30, 2010, Fannie Mae filed Fannie Mae's Report On Status of Production (Doc. No. 109) ("Report"). The Report set forth the minimal production received by Fannie Mae. No further production has been furnished to Fannie Mae or the State Court Receiver since the date of the Report. Fannie Mae is unaware of any production covered by this Motion to the Trustee herein. Fannie is not satisfied with the progress of production.

WHEREFORE, Fannie Mae requests that the Court issue an Order on the Motion to Compel.
