**ORDER (i) MODIFYING DOCUMENT SUBPOENA TO GRAVES & CO. CONSULTING
LLC (ii) SUSTAINING IN PART DEBTORS' OBJECTION TO SAME
AND (iii) GRANTING IN PART DEBTORS' MOTION TO QUASH**

Upon the Objection to Document Subpoena to Graves & Co. Consulting LLC ("Graves") and Motion to Quash (the "Motion") filed by the above-captioned debtors and debtors in possession (collectively, the "Debtors");² and the Court having jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334; and this matter being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue before this Court being proper pursuant to 28 U.S.C. § 1408 and 1409;

and upon the arguments and representations of counsel at the hearing on the Motion conducted on May 29, 2019 (the “Hearing”); and after due deliberation and good cause appearing therefor, it is

ORDERED AS FOLLOWS:

1. The Motion is granted, in part, and denied, in part, for the reasons stated on the record at the Hearing.
2. The Subpoena is hereby modified to request production of only responsive and discoverable documents dated between December 20, 2017 and October 30, 2018.
3. Graves shall comply with the terms of the Subpoena, as modified herein.
4. By agreement of the parties, Graves shall have until June 14, 2019 to comply with the terms of the Subpoena, as modified herein.
