# DECLARATION OF BALLOTING AGENT REGARDING SOLICITATION AND TABULATION OF VOTES IN CONNECTION WITH THE DEBTORS' <u>AMENDED JOINT CHAPTER 11 PLAN</u>

Varouj Bakhshian, declares pursuant to 28 U.S.C. § 1746, as follows:

- 1. I am over eighteen years of age and not a party to the above-captioned cases. I am employed as a Senior Director by BMC Group, Inc. ("BMC"), the balloting agent for the above-captioned debtors and debtors in possession (collectively, the "Debtors") in these chapter 11 cases. My business address is 3732 W. 120<sup>th</sup> Street, Hawthorne, California 90250.
- 2. On August 27, 2019 the Court entered its *Order Approving Disclosure Statement*, *The Form Of Ballots And Solicitation Procedures, Scheduling Certain Dates in Connection With Confirmation; and Granting Related Relief* [Docket No. 246] (the "Disclosure Statement Order"), which approved the *Disclosure Statement For Debtors' Amended Joint Chapter 11 Plan* [Docket No. 251] (the "Disclosure Statement").

3. Under the terms of the *Debtors' Amended Joint Chapter 11 Plan* [Docket No. 251] (the "<u>Joint Plan</u>"), all Claims against and Equity Interests in the Debtors, except Administrative Claims and Priority Tax Claims, are treated as follows for purposes of voting:<sup>2</sup>

- 4. In accordance with the Disclosure Statement Order, BMC served solicitation packages containing the following via U.S. Postal Service First Class Mail on August 30 2019 (the "Solicitation Packages"):
  - a) The Joint Plan, Disclosure Statement, Disclosure Statement Order and the Motion Pursuant to Section 541 (a) of the Bankruptcy Code for Determination that Certain Claims and Causes of Action are Property of the Estate (the "Determination Motion") [Docket No. 137] on CD-ROM;
  - b) The Notice Of Hearing To Consider Confirmation Of Debtors' Amended Joint Chapter 11 Plan And Related Deadlines [Docket No. 249] (the "Confirmation Hearing Notice");
    - c) The ballots for Class 4 Equity Interests;

- d) The Debtors', PDC Energy, Inc. and the LP Plaintiffs' Solicitation Recommendation Letter (the "Solicitation Letter");
- e) The Notice of Technical Correction to Solicitation Versions of (I) Disclosure Statement for Debtors' Amended Joint Chapter 11 Plan and (II) Debtors' Amended Joint Chapter 11 Plan ( the "Notice of Technical Correction") [Docket No. 252]; and
  - f) A self-addressed return envelope.
- 5. The Joint Plan, Disclosure Statement, Disclosure Statement Order, Determination Order, Confirmation Hearing Notice, Solicitation Letter and Notice of Technical Correction were also posted to the BMC Website at <a href="https://www.bmcgroup.com/rockiesregion">www.bmcgroup.com/rockiesregion</a>.
- 6. A certificate evidencing service of the solicitation packages was filed with the Court on September 9, 2019 [Docket No. 253].
- 7. Pursuant to the Disclosure Statement Order, the Court established September 27, 2019 at 5:00 p.m. prevailing central time as the Voting Deadline.
- 8. The Disclosure Statement, Joint Plan and Disclosure Statement Order served as BMC's guide for the solicitation and tabulation of votes to accept or reject the Joint Plan, and all ballots received were reviewed and tabulated in accordance with the procedures described therein.
- 9. In addition, the Debtors provided BMC with a list of all Equity Interest holders and their investments in both dollar amounts and number of partnership units as of the Voting Record Date (the "Equity Interest Holder Investment List"). This list was used by BMC to provide in the footer of the Equity Interest holders' Class 4 ballot their investment in both dollar amount and number of partnership units and provide information to Equity Interest Holders who called into BMC's toll free call center with questions about the dollar or unit amounts of their DECLARATION OF BALLOTING AGENT REGARDING SOLICITATION AND TABULATION OF VOTES PAGE 3

investments. BMC also used the Equity Holder Investment List to audit the ballots cast by Equity Interest holders, as described below.

- 11. Attached hereto as <u>Exhibit A</u> is the full tabulation report that provides both a summary of, and the detail behind, all ballots received as of the Voting Deadline of September 27, 2019 for the Joint Plan. <u>Exhibit A</u> also sets forth whether any ballots cast were excluded from tabulation and the basis for such exclusion.
- 12. Ballots may have been excluded for one or more of the following reasons, as reflected on Exhibit A:
  - (a) Not Entitled To Vote In This Class this exclusion indicates that an Equity Interest holder asserted a vote amount in units or dollars (including using "all" or "unknown") in a class for which the Equity Interest holder does not hold an interest, as indicated by the Equity Interest Holder Investment List. To the extent an Equity Interest holder's ballot voted in multiple classes, the ballot was counted to the extent the holder voted in an appropriate class, and excluded for the remaining classes.
  - (b) <u>Ballot did not indicate an acceptance or rejection of the Plan</u> this exclusion indicates that neither the Accept nor the Reject option was selected on the ballot.
  - (c) <u>No Signature</u> this exclusion indicates that the ballot was not signed.
  - (d) <u>Incomplete</u> this exclusion indicates that no voting class was selected or pages are missing from the ballot.
  - (e) <u>Duplicate</u> this exclusion indicates that the ballot is identical to another ballot received on the same day. If duplicate valid ballots were submitted by an Equity Interest holder (for example, one by fax and one by email), only the duplicate(s) was (were) excluded; one valid ballot was counted.

- (f) Supersede this exclusion indicates that a later filed ballot superseded the original ballot. The later filed ballot was counted; the first-filed ballot was excluded. The difference between a superseded ballot and a duplicate ballot is (i) the ballots were received on different days or (ii) the later filed ballot reflected a different vote or different information than the first filed ballot.
- (g) <u>Late Filed</u> this indicates that a ballot was received after the Voting Deadline.
- or a "no" is reflected for each ballot received. This column, and the "yes" or "no" reflected therein, indicates an Equity Interest holder's decision to opt-out of the direct release for PDC Energy, Inc, in its capacity as general managing partner for each Debtor. Pursuant to the instructions on the ballot, if the holder of an Equity Interest checked the box on the ballot to "Opt-Out of Direct Release," Exhibit A reflects a "yes" for such holder (that is, "yes, such holder checked the box and opted out"). If a holder did not check the box and, thus, consented to the release, Exhibit A reflects a "no" for such holder (that is, "no, such holder did not check the box and thus consented to the release"). Exhibit A reflects the opt-out choice made by voters, regardless of whether their ballots were valid and counted, or excluded.
- 14. All ballots received by BMC are stored at BMC's office located at 3727 W. 120<sup>th</sup> Street, Hawthorne, California 90250 and are available for inspection by the Court or any party in interest.
