**ORDER GRANTING FIRST AND FINAL APPLICATION
OF GRAY REED & McGRAW LLP FOR ALLOWANCE OF

Upon the *First and Final Application of Gray Reed & McGraw LLP for Allowance of Compensation and Reimbursement of Expenses for the Period October 30, 2018 through October 21, 2019* [Docket No. 288, as supplemented by Docket No. 295] (the “Application”); and the Court having jurisdiction over the Application pursuant to 28 U.S.C. §§ 157 and 1334; and the Application being a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and it appearing that good

and sufficient notice of the Application has been given and no other or further notice is required; and after due deliberation and good cause appearing therefor,¹ it is

ORDERED that the Application be, and it hereby is, granted as set forth herein; and it is further

ORDERED that final compensation and reimbursement of expenses to Gray Reed is hereby allowed and approved in the aggregate amount of \$1,046,546.50 in fees and \$21,100.15 in expenses for the Application Period; and it is further

ORDERED that Gray Reed is hereby authorized to draw down the Retainer in the amount of \$17,000.00 in partial satisfaction of the fees and expenses approved herein, with the balance to be paid from the Administrative Reserve; and it is further

ORDERED that the Court retains jurisdiction over this Order and the matters addressed herein.
